INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

INVESTMENT PROCESS

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Market Context

Despite the headlines and market turbulence, the first month of 2025 delivered solid returns for equity investors. The MSCI World Index regained its footing after December's dip, closing the month up 3.53% and just shy of its all-time highest levels. The US market, despite spiked heart rates following China's DeepSeek scare during the latest episode of the AI race, was buoyed by strong macroeconomic data and the promise of market-positive policies from the incoming administration. The S&P 500 Index returned 2.78% for the month. Across the pond, European markets, with relatively lower exposure to the technology sector, surged ahead. The Euro Stoxx Index delivered an impressive 7.89% return for the month as companies reported positive earnings surprises for the previous quarter.

China's CSI 300 Index bucked the trend, giving back 2.26% in US dollars as market participants braced for a potential tariff-led trade war with the US. Meanwhile, Japan's Nikkei 225 Index closed marginally higher, up 0.72% in US dollars, after the Bank of Japan raised rates by another 25 basis points. The broader emerging markets continued to lag behind the developed markets. The MSCI Emerging Markets Index closed the month up 1.79%, with relative valuations increasingly attractive.

The domestic equity market was boosted by the resources sector, which rose 17.91% this month, recovering from what was a poor final quarter last year. The FTSE/JSE All Share Index closed the month up 2.32%, as the rand gained 0.93% against the US dollar following the Reserve Bank's decision to cut interest rates by 25 basis points.

Fund Positioning

The Fund maintains maximum effective exposure to the large- and mid-cap sectors of the market. This equity exposure consists of the top three allocations to the technology, financials, and consumer discretionary sectors, with the largest share exposures to Apple, NVIDIA, and Microsoft.

Outlook

Our moderately positive outlook for the local equity market remains unchanged. Despite marginal weakening during the month, our valuation and sentiment indicators continue to support this view, alongside improving economic and financial conditions. We remain neutral on the local Listed Property sector and US equities.

Fund Performance

The Fund generated a return that outperformed the benchmark index over the past month. This performance aligns with the investment process and the systematically risk-managed investment philosophy employed to achieve consistent long-term outperformance.

Contributors and Detractors

The top contributors to the Fund's performance in January were Gold Fields (+30.9%), AngloGold (+34.3%), and Richemont (+30.7%). Detractors included Naspers (-5.4%), Capitec (-5.2%), and Mr Price (-15.4%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
