INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the FTSE/JSE Africa All Share Total Return Index at low cost. Although the Fund is structured similarly to the All Share, it can out / underperform the All Share by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the FTSE/JSE Africa All Share Total Return Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. In addition to investing in physical assets, the Fund can use derivatives to create exposure to the FTSE/JSE Africa All Share Total Return Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through exposure to the South Africa equity market by investing in a fund with a low tracking error relative to the FTSE/JSE Africa All Share Total Return Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Market Context

Despite the headlines and market turbulence, the first month of 2025 delivered solid returns for equity investors. The MSCI World Index regained its footing from December's slip up to close the month up 3.53% and just off its all-time highest levels. The US market, notwithstanding spiked heart rates following China's DeepSeek jump scare during this latest episode of the AI-making-race, was buoyed by strong macro economic data and the promise of the incoming administrations' market positive policies. The S&P 500 Index returned 2.78% for the month. Across the pond, European markets, with relatively lower concentration levels to the technology sector shot out of the blocks. The Euro Stoxx Index delivered an impressive 7.89% return for the month as the companies delivered positive earnings surprises for the previous quarter.

China's CSI 300 index bucked the trend, giving back 2.26% in US dollars as market participants brace for a potential tariff led trade war with the US whilst Japan's Nikkei 225 Index closed marginally higher, up 0.72% in US dollars after the Bank of Japan continued to hike rates by another 25 basis points this month. The broader Emerging Markets continued to lag the broader developed markets. The MSCI Emerging Markets Index closed the month up 1.79% with relative valuations increasingly attractive.

The domestic equity market was higher by the resources sector which was up 17.91% this month, bouncing back from what was a horrid final quarter last year. The FTSE/JSE All Share Index closed the month up 2.32% as the rand gained 0.93% against the US dollar following the Reserve Bank's decision to cut interest rates by 25 basis points.

Fund Positioning

The Fund maintains the maximum effective exposure to the large- and mid-cap sectors of the market. This equity exposure consists of top three allocations to the financials, basic materials, and technology sectors, with the largest share exposures to Naspers, FirstRand Bank, and Standard Bank.

Outlook

Our moderately positive outlook for the local equity market remains unchanged. Notwithstanding marginal weakening during the month, our valuation and sentiment indicators continue to underpin this view alongside improving economics and financial conditions indicators. We remain neutral on the local listed property sector and US equities.

Fund Performance

The Fund has delivered returns in line with, and marginally ahead of the benchmark index over the last month. This performance is in line with the investment process and systematic risk managed investment philosophy employed to deliver consistent long-term outperformance.

Contributors and Detractors

The top contributors to the Fund's performance in January were Gold Fields (+30.9%), AngloGold (+34.3%), and Richemont (+30.7%). Detractors included Naspers (-5.4%), Capitec (-5.2%), and Mr Price (-15.4%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
