INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment policy which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI World Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Market Context

Equity markets delivered a mixed bag of returns largely attributed to a resounding victory for the Conservative Republican Party in the US elections. US stocks rallied as Donald Trump was voted into office and market participants positioned themselves for what has been promised to be an expansionary fiscal policy administration. This led Developed Markets higher as the MSCI World index closed the month up 4.59% while the S&P 500 index posted a solid 5.87% return for the month. The rest of the world was seemingly less enthusiastic about the prospect of an increasingly US-centric policy environment and the palpable threat of trade wars in what is still a dollar led global economy. Across the pond, The Euro Stoxx 600 index gave back 2.79% for the month as the earnings outlook for the region deteriorated. Further east, Japan and China similarly closed the month lower in hard currency in the wake of a rampant US dollar. The Nikkei 225 and CSI 300 indices gave back 0.55% and 1.13% respectively. The broader Emerging Markets were not spared as the MSCI EM index closed 3.59% lower.

Fund Positioning

The Fund maintains the maximum effective exposure to the large and mid-cap sectors of the market. The top three sector allocations for this equity exposure were Information Technology, Financials and Industrials sectors, with largest share exposures to Apple, NVIDIA and Microsoft.

Outlook

Our outlook has shifted from strongly negative to moderately negative, reflecting improvements in both economic conditions and market sentiment, despite valuations remaining significantly stretched. Enhanced sentiment has been supported by a resilient consumer base and strengthening business confidence. Additionally, U.S. economic growth, as indicated by the Prescient Economic Indicator, has shown improvement.

Fund Performance

The Fund was up 4.42% in November, underperforming the benchmark, which rose 4.57%. YTD, the Fund is behind the benchmark by 0.71%, with a return of 18.68%.

Contributors and Detractors

The positions that contributed most to the absolute performance of the Fund for the month were Tesla (+52.7%), Amazon (+11.5%) and Apple (+5.1%). The largest detractors from the month's absolute performance were AbbVie (-10.3%), Broadcom (-4.5%) and Eli Lilly (-4.1%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Foreign Investment risk: Foreign securities investments may be subject to risks pertaining to overseas jurisdictions and markets, including (but not limited to) local liquidity, macroeconomic, political, tax, settlement risks and currency fluctuations.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Geographic / Sector risk: For investments primarily concentrated in specific countries, geographical regions and/or industry sectors, their resulting value may decrease whilst portfolios more broadly invested might grow.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

Liquidity risk: If there are insufficient buyers or sellers of particular investments, the result may lead to delays in trading and being able to make settlements, and/or large fluctuations in value. This may lead to larger financial losses than expected.

Equity investment risk: Value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. In the event of a company default (e.g. bankruptcy), the owners of their equity rank last in terms of any financial payment from that company.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
