## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

### INVESTMENT PROCESS

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

### WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

Despite ending on a positive note, global equity markets were notably unsteady going into August. A dangerous mix of underwhelming earnings—particularly from the U.S. technology sector—combined with weak labor market data hinting at an economic slowdown, a major yen-funded carry trade unwind from Japan, and escalating geopolitical tensions in both the Middle East and Russia, sent a stunning shockwave through the markets. The MSCI World Index lost 6.40% in just the first three trading days of the month, while the VIX Index spiked over twenty points to reach levels last seen in 2020. The bears eventually calmed down as the month progressed, and regular programming resumed. Softer inflation numbers and dovish commentary once again provided the tailwind for firmer market performance. The MSCI World Index concluded the month up 2.64%, while the S&P 500 Index in the U.S. gained 2.43%. European markets, although still playing catch-up to their U.S. counterparts, were similarly strong, with the Eurostoxx posting a solid 3.74% gain. Local currency depreciation in Japan helped the Nikkei achieve a positive 1.77% return in U.S. dollars. Emerging markets were broadly firmer in August, although the MSCI EM Index posted a relatively modest 1.61% return, largely moderated by weakness in China, where the CSI 300 Index gave back 1.77%.

The MSCI EM TR Net Index (USD) returned 1.61% for the month, bringing its year-to-date performance to 9.55%. The Fund was marginally behind the benchmark for the month, gaining 1.22% (gross of fees).

### Contributors to Performance:

The positions that contributed most to the absolute performance of the Fund for the month were Naspers (+4.42%), Standard Bank Group (+8.22%) and FirstRand Limited (+5.24%).

### Detractors from Performance:

The largest detractors from the month's absolute performance were Gold Fields (-22.32%), Impala Platinum (-17.38%) and Northam Platinum (-26.10%).

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

**Interest rate risk:** The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
