INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST




FUND COMMENTARY

Global markets advanced in October, supported by resilient earnings and easing inflation, even as policymakers navigated a complex mix of geopolitical tension, shifting trade alignments and year-end monetary decisions. Performance diverged meaningfully across regions: the MSCI World Index rose 2.0% and the MSCI Emerging Markets Index gained 4.18%, maintaining year-to-date leadership at 32.86%. Overall sentiment remained positive, though valuations across major developed markets are elevated.

In the US, a government shutdown triggered a historic data blackout, limiting visibility for policymakers ahead of the Federal Reserve's widely expected 25 bps rate cut. Trade relations shifted after a high-profile meeting between the US and China resulted in tariff reductions and commitments to restore commodity flows. The S&P 500 rose 3.0%, supported by technology and financials, although sector-level performance was mixed. Europe showed tentative signs of stabilisation as inflation eased, with the Eurostoxx up 0.31% for the month.

In Asia, performance was more varied but included some of the strongest gains globally. Japan led, with the Nikkei 225 surging 11.83% to new highs on continued enthusiasm for AI and semiconductor activity. China's equity market was broadly flat, although industrial momentum improved. Fragile domestic demand and property-sector uncertainty continued to temper the impact of earlier policy support. Inflation remained near zero despite fiscal stimulus, underscoring the absence of meaningful pricing pressure.

The top contributors to the Fund's performance for the month were NVIDIA (8.53%), Amazon (11.23%), and Alphabet (15.67%). Detractors included Meta Platforms (-11.71%), Berkshire Hathaway (-5.01%), and Netflix (-6.68%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

% Property risk: Investments in real estate securities can carry the same risks as investing directly in real estate itself. Real estate prices move in response to a variety of factors, including local, regional and national economic and political conditions, interest rates and tax considerations.

Geographic / Sector risk: For investments primarily concentrated in specific countries, geographical regions and/or industry sectors, their resulting value may decrease whilst portfolios more broadly invested might grow.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

Equity investment risk: Value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. In the event of a company default (e.g. bankruptcy), the owners of their equity rank last in terms of any financial payment from that company.

During the phase in period TER's do not include information gathered over a full year. Transaction Costs(TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
