



Investment Objective

The Fairtree ALBI Plus Prescient Fund will aim to deliver an annualised return of ALBI plus 1%, after fees, which comprises a reasonable level of income as well as capital performance. Due to the nature of the bond type investments, the majority of the returns through the cycle will be through quarterly income distributions. The Fund invests in a diversified and balanced range of asset classes and may invest in offshore securities when the benefit of higher returns and portfolio diversification are available.

Investment Policy

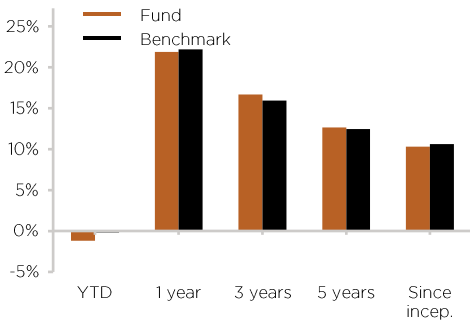
The main objective of the fixed income team is to provide superior risk-adjusted returns over and above the published All Bond Index (ALBI) to our clients irrespective of market conditions. We believe that markets are not always efficient and therefore present mispriced opportunities, which can be taken advantage of to generate excess returns. We aim to seek out mispriced risk in the market consisting of inter and intra market arbitrage. The fund looks to take advantage of any short or long-term anomalies in the market, whilst minimising any risks associated with running those positions.

A disciplined approach to quantitative analysis within a team framework can help identify these mispriced assets. We believe that a team based quantitative approach to the valuation of assets, combined with cutting edge portfolio construction techniques and risk management help build a fund to achieve the stated objectives of superior risk adjusted returns.

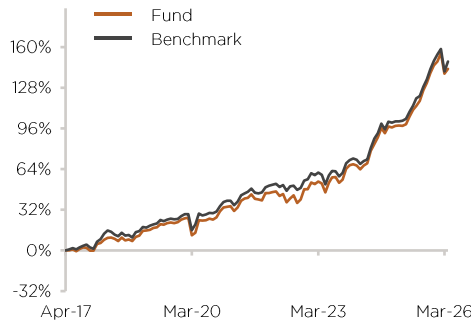
RISK INDICATOR

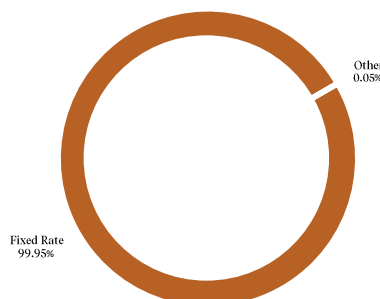

MARKET COMMENTARY

The South African All Bond Index (ALBI) delivered a strong return of 3.27% in April, as bond yields retraced a significant portion of March's sharp sell-off. The R2030 yield decreased by 14.5 basis points (bps), while the longer-dated R2053 yield declined by 46 bps. Local equities also recovered modestly, with the Top 40 Total Return Index gaining 1.56%, while STEFI returned 54 bps.

The Fairtree ALBI Plus Prescient Fund returned 1.50% during the month, underperforming its ALBI benchmark by 1.77% but outperforming STEFI by 96 bps. Credit markets recovered following March's widening, with the iTraxx Main and Xover indices tightening by 12 bps and 61 bps, respectively, while the Republic of South Africa and Eskom CDS spreads tightened by 39.5 bps and 23.5 bps, respectively.

On the interest rate front, the fund is aligned with the ALBI benchmark from a modified duration perspective, while maintaining a relatively short convexity position. The fund managers continue to seek opportunities to enhance yield pickup relative to the benchmark through both interest rate and credit positioning.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

High Water Mark: The highest level of performance achieved over a specified period.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
