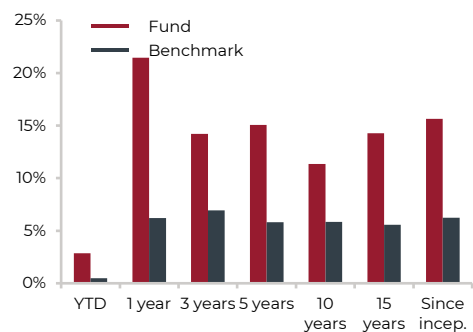

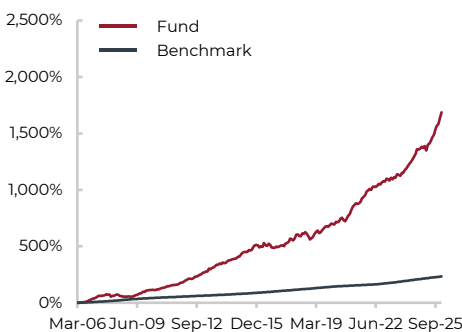
RISK INDICATOR

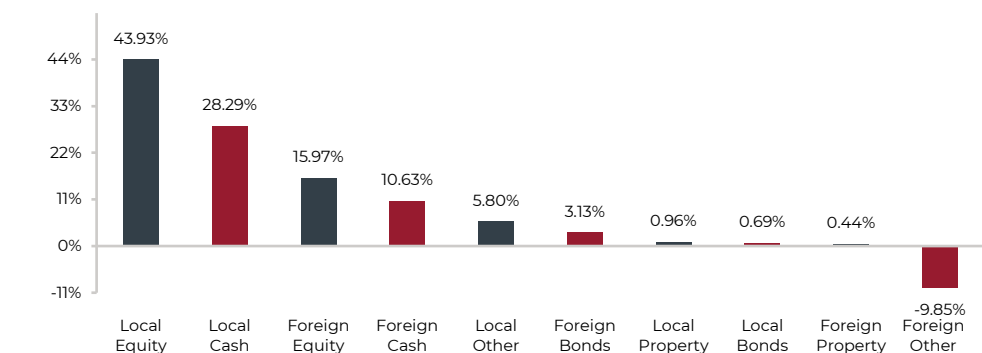

FUND COMMENTARY

South African assets delivered another exceptionally strong quarter, extending an unprecedented rally in domestic markets. Listed property was a standout performing asset class, advancing +13.4% QoQ as it benefited from falling bond yields and improved funding conditions, while bonds followed closely, delivering a strong +9.0% QoQ return as yields declined sharply across the curve. Equities also posted solid gains, delivering a strong +7.3% QoQ in Q4, as the FTSE/JSE All Share Index advanced for a tenth consecutive month and surpassed the 117,000-point level during the quarter. Financial stocks led equity performance, with the FTSE/JSE Financial 15 Index up +17.5% QoQ, followed by resource stocks which gained +10.0% QoQ while industrial stocks went backwards to the tune of -2.5% over the quarter. In US dollar terms, South African equities significantly outperformed global peers, with the MSCI South Africa rising +13.6% QoQ, ahead of the MSCI World (+2.9% QoQ) and MSCI Emerging Markets (+4.3% QoQ), supported by a firmer rand and sustained foreign inflows. Sentiment was further bolstered by South Africa's removal from the FATF grey list and a sovereign credit rating upgrade, reinforcing the country's investment case and underpinning robust quarter-end momentum.

Global equity markets posted more modest gains in Q4 following a strong run earlier in the year, as investors became increasingly selective amid elevated valuations, particularly within the AI and mega-cap technology complex. The MSCI World Index ended the quarter up +2.9% QoQ, supported by easing trade tensions, resilient corporate earnings, and expectations of continued monetary policy easing into 2026. Commodities delivered a mixed performance. Precious metals were firm, supported by lower real yields and central bank buying. Gold reached fresh all-time highs above US\$4,500/oz, advancing +11.9% QoQ, while platinum outperformed, rising +30.8% QoQ over the quarter. In contrast, energy markets softened, with Brent crude dipping below US\$60/bbl and declining -9.2% QoQ amid oversupply concerns and tentative geopolitical de-escalation. Bond yields generally trended lower across developed markets, providing a supportive backdrop for risk assets despite periods of consolidation towards year-end.

South Africa's macroeconomic backdrop strengthened materially over Q4, reinforcing the strong performance of local assets. Inflation remained well contained near the SARB's preferred 3% anchor, while fiscal credibility improved following a market-friendly Medium Term Budget Policy Statement and a sovereign credit rating upgrade. The SARB delivered a 25bps rate cut in November, bringing cumulative easing to 100bps for the year, while bond yields declined to multi-year lows (ending the year at c. 8.2%) as issuance expectations were reduced and foreign demand increased.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

A "qualified investor" means any person, who invests a minimum amount of R1 million per hedge fund and who:

1. Has demonstrable knowledge and experience in financial and business matters which would enable the investor to assess the merits and risks of a hedge fund investment, or
