The Fund's investment objective is to achieve long term capital growth by investing in global equity markets.

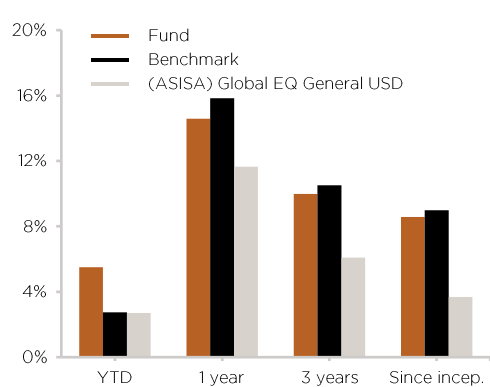
Risk Indicator Definition

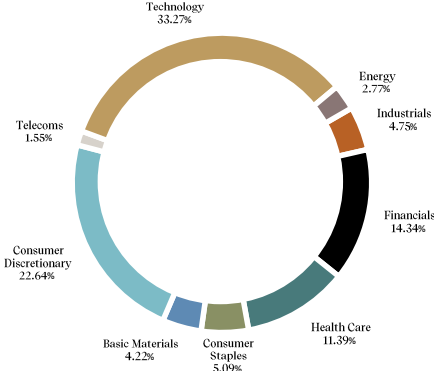

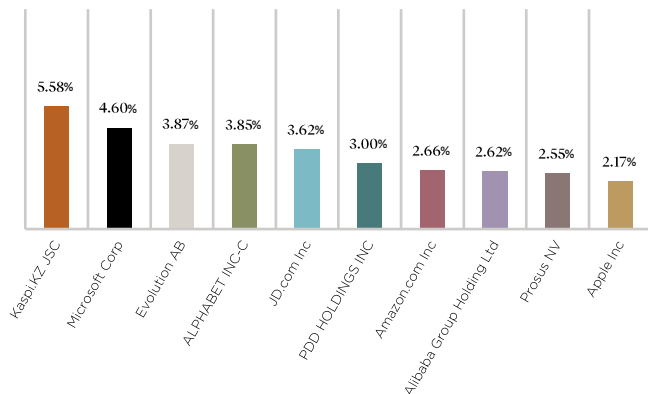

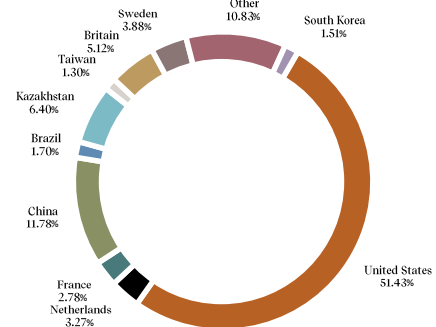

MARKET COMMENTARY

The Fund returned 0.49% for the month, outperforming the benchmark by 1.1%. Global markets saw a reversal in February, with the MSCI ACWI decreasing -0.6% off the back of a strong performance in January. The MSCI Emerging Markets Index increased by 0.48% (all in USD). MSCI ACWI and MSCI EM saw China posting positive returns, increasing by a substantial 11.8%. Germany and the UK also saw notable gains, increasing by 3.9% and 3.5%, respectively.

US equities ended the month 1.6% lower, driven by several significant economic developments and uncertainty around the impact of policies pursued by the White House. As expected, the Fed's preferred inflation measure, monthly core PCE, rose 0.3% in January. There was some evidence that consumers are pulling back as inflation-adjusted consumer spending fell 0.5%, marking the biggest monthly decline in almost four years. The Atlanta Fed's GDP Now series plummeted to -2.4, having only ever been lower in the COVID-19 downturn and in July 2022. European shares rose 3.7% in February. Inflation in Europe decreased to 2.4% in February, down from 2.5% in January, reinforcing expectations for the ECB to cut interest rates at their upcoming meeting. The conclusion of German elections and subsequent fiscal policy announcements saw equity markets responding positively to the anticipated economic stimulus measures. The Bank of England cut interest rates by 25bps to 4.5%, as a response to a mix of slow economic growth, stubborn inflation and tariff threats. Within emerging markets, China experienced a strong rally, increasing 11.8% over the month, driven by government initiatives aimed to stabilise the economy, such as reduced interest rates, financial support for the property sector, and increased liquidity. Advancements in AI by Chinese companies have reshaped investor sentiment, reinforcing their position as a major force in the technology sector.

On a sector level, Consumer Discretionary and Information Technology were the worst-performing sectors over the month. Financials, where the Fund is underweight, was the best-performing sector. Stock picking within the Consumer Discretionary and Financials sectors added to relative performance.

Noteworthy portfolio actions over the month included selling the Fund's positions in Goldfields, Humana Inc., Nestle, Infineon and Koninklijke Ahold Delhaize. Following strong performance, we also trimmed our position in Alibaba, PDD Holdings and Capgemini. The existing positions in technology names - Microsoft, Nvidia and Alphabet - were topped up. New positions were initiated in Merck & Co and Global Payments. Both companies are growing earnings at a pedestrian pace but have derated to 10x price/earnings, offering an attractive entry point.

Notable contributors to Fund performance were positions in Alibaba (+95 bps absolute, +85 bps relative), Kaspi (+52 bps absolute and relative) and Prosus (+31 bps absolute, +30 bps relative). Alibaba reported strong results showing that the core business is returning to growth while continuing to return cash to shareholders via share buybacks. Notable detractors from performance over the month came from Alphabet (-68 bps absolute, -23 bps relative), Amazon (-29 bps absolute, 0 bps relative) and Microsoft (-20 bps absolute, -4 bps relative).

The Fund is positioned with a large underweight in cyclical names, as we see a growing risk of a slowdown in the US economy. The strong rally in our Chinese e-commerce holdings was used to reduce the emerging market technology exposure. We redeployed some cash into developed market technology names, although we maintain an underweight position. The Fund remains overweight in China through the Chinese technology shares and overweight in Kazakhstan through Financial shares.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Specific Risk
