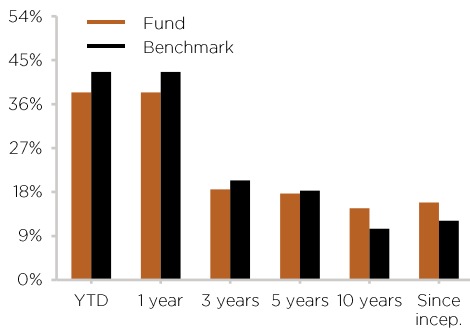
### Investment Policy

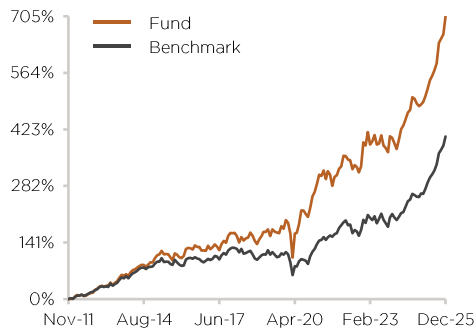


### ANNUALISED PERFORMANCE (%)

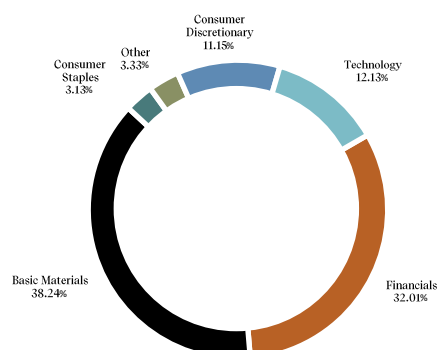

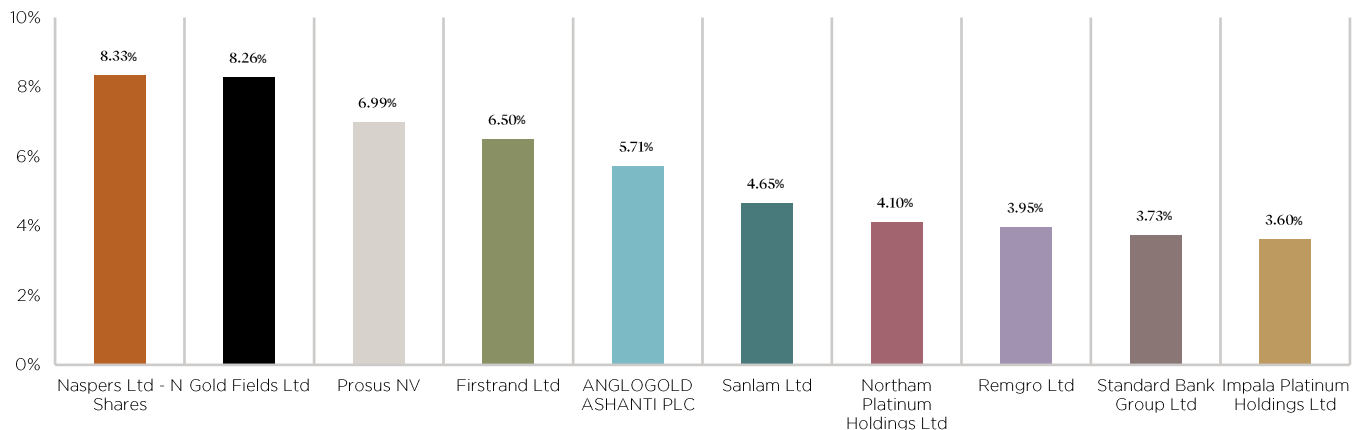

### MARKET COMMENTARY

The FTSE/JSE All Share Index (ALSI) increased by 4.6% in December 2025. The FTSE/JSE Shareholder Weighted Index (SWIX) also increased by 4.6%, and the FTSE/JSE Capped Shareholder Weighted Index (Capped SWIX) increased by 5.2%. The rand strengthened by 3.2% during the month. Resources, Industrials and Financials increased by 5.7%, 1.9% and 7.7%, respectively.

During December, bonds increased by 2.7%, and cash returned 0.6%. The MSCI Emerging Markets Index increased by 3.0% (USD), outperforming the MSCI World Index, which increased by 0.8% (USD). The MSCI South Africa Index increased by 9.1% (USD).

Over December, iron ore increased by 2.6% to US\$103.6/t, and thermal coal increased by 1.3% to US\$86.2/t. Brent crude oil decreased by 1.8%, closing the month at US\$60.9/bbl. Gold was up by 1.9% to US\$4319.4/oz, and platinum increased by 23.3% to US\$2060.5/oz. Palladium increased by 11.4% to US\$1620/oz.

December 2025 delivered the soft-landing confirmation investors had been hoping for. The month was marked by the highly anticipated December 16 "Super-Release" of employment data, which ultimately clarified the post-shutdown economic picture. This data, combined with a subsequent Federal Reserve rate cut, ignited a broad-based "Santa Rally" that lifted global equities, including the JSE.

Commodities were a key driver of market narrative: gold traded near fresh record highs as investors sought protection from policy and geopolitical risk, while copper extended a powerful rally to new all-time highs above \$12,000/t on fears of a looming structural shortage and tariff-related dislocations. Oil, by contrast, remained range-bound as evidence of a growing supply surplus offset sporadic geo-risk spikes. The US dollar softened over the year as rate cuts accumulated and fiscal concerns rose, providing a more supportive backdrop for higher-yielding emerging markets.

Resource counters continued to lead the charge, supported by record gold prices and a sharp rerating in platinum-group metals and copper-exposed names. Strong moves in platinum-group metals were underpinned by policy signals that effectively extend the life of the ICE (internal combustion engine) fleet. Banks benefited from the combination of easing sovereign risk, stabilising credit trends and still-attractive starting valuations, and pre-close updates generally pointed to solid earnings momentum and healthy capital positions.

Company-specific news included the announcement of the proposed acquisition of European value retailer NKD by Mr Price, which was a detractor from performance.

The VIX Index (volatility or "fear" index) decreased by 8.6% during the month.

The Fund's performance was positively impacted by positions in Impala (22.20%), FirstRand (11.39%), Northam Platinum (10.35%) and Standard Bank (10.16%), while Mr Price (-15.20%), Prosus (-3.70%), AngloGold (-0.84%) and Sasol (-4.58%) detracted from performance.

The Fund invests in several focused strategies. The Fund maintains overweight positions in cyclical (diversified mining) and defensive (gold mining, global industrials) strategies, and we prefer higher-quality names over lower-quality ones (local consumer discretionary, financials).



#### Glossary

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**High Water Mark:** The highest level of performance achieved over a specified period.

**Performance Fee Cap:** The maximum performance fee that can be charged over a specified period

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

**Transaction Costs (TC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

#### Specific Risk

The portfolio has adhered to its object and there were no material changes to the composition of the portfolio during the quarter.

#### Risk Indicator Definition

The Portfolio is more diversified than the benchmark, thus holding smaller positions in the largest capitalisation stocks than the benchmark. This comes with the risk of more volatile relative returns to the broader market when the largest stocks in the benchmark outperform. We believe however that this strategy of holding a more diversified portfolio results in lower single stock risk, and whilst there may be periods of underperformance when the large cap stocks rally, we firmly believe in efficient risk management on an absolute basis. The strategy is also exposed to various factors driving investment performance, for example Value and Momentum, and these factors may also experience periods of relative underperformance. Global research has shown however, that consistent long term exposure to these factors lead to investment reward. This portfolio is permitted to invest in foreign securities which may have additional risks (FX Movements for example). However, the portfolio does not currently hold any foreign securities and the manager does not intend on exposing the portfolio to any foreign securities going forward.
