

Investment Objective & Strategy

The **WealthStrat Growth Prescient Fund of Funds** will aim to deliver moderate to high long term total return. The manager shall have limited flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The Fund will employ asset and limited geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **WealthStrat Growth Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 75%. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time.

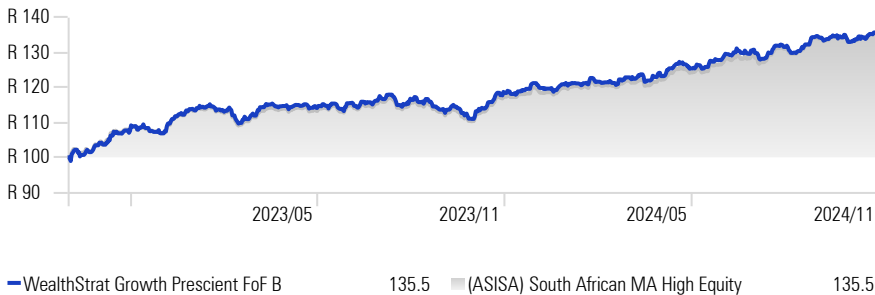

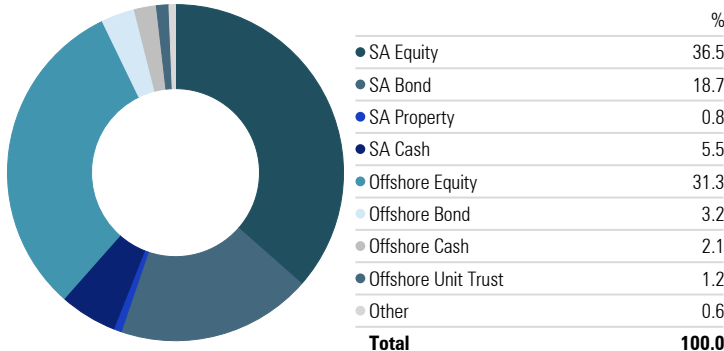

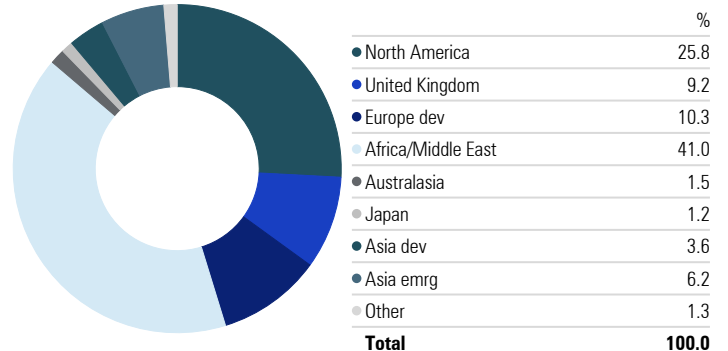

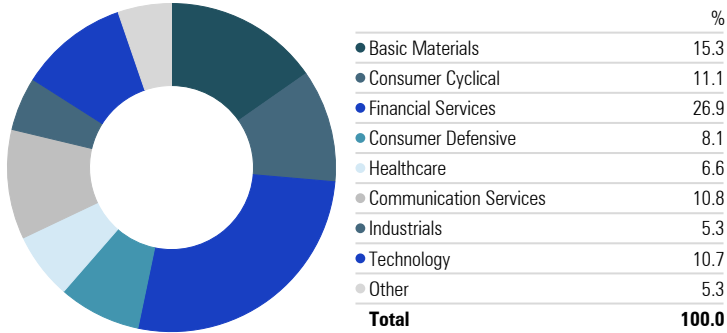
Equity Regional Exposure

Quarterly Fund Commentary

Moderately aggressive investors achieved solid returns in the third quarter of 2024, driven by the strong performance of most risk assets. Positive investor sentiment led to a strong performance from local equities, benefitting the Portfolio. Additionally, robust local bond performance further enhanced overall returns. On the other hand, the appreciation of the rand during the quarter posed a headwind for the Portfolio's global allocations.

The WealthStrat Growth Prescient Fund of Funds returned +5.2% for the quarter and has generated a return of +18.4% over the past year.

The portfolio remains diversified in terms of its exposure to different asset classes, and we remain confident in its ability to deliver inflation-beating returns over the long term, independent of the market environment.

Asset Allocation

Local equities make up the largest allocation in the portfolio. Local equities moved higher, driven largely by the Financials (+13.7%) and Industrials (+11.6%) sectors. Large banking and insurance counters produced double-digit returns on the back of general strength in the sector. Momentum (+28.7%), Discovery (+27.6%), OUTsurance Group (+25.0%) and Capitec (+18.0%) were among the best-performing counters in the sector over the quarter. S.A. Industrials (+11.6%) ended the quarter in positive territory, largely driven higher by "S.A. Inc" shares and in particular S.A. retailers, which rebounded strongly. Mr. Price (+34.4%), Foschini (+24.3%), Spar Group (+14.5%) and Shoprite (+5.7%) ended the quarter posting robust returns. In addition, index heavyweights Naspers (+17.6%) and Prosus (+16.2%) delivered strong returns on the back of the performance recorded by Tencent after the recent stimulus announcement in China. SA resources (-1.5%) ended the quarter lower, dragged lower by Energy and Platinum shares including African Rainbow Minerals Ltd(-16.6%) and Sasol (-16.0%). Global equities produced strong returns this quarter with the strength in non-US stocks being a major development this quarter. The broad MSCI EAFE (developed markets excluding the US and Canada) Index gained 7.3%, ahead of the S&P 500's 5.9% return. Emerging Markets performed even better, advancing 8.7% in US dollar terms. China, the largest component of the Index, soared by 23.5% during the quarter, with most of this gain occurring in the quarter's final days following the announcement of stimulus measures by the Chinese government. Local bonds make up the next largest allocation within the Portfolio. This includes allocations to corporate, government and inflation-linked bonds. Short-dated nominal bonds held up well over the quarter and produced a stable performance, however, they lagged the performance of longer-duration peers. Longer-dated instruments ended the quarter higher as yields moved lower (and prices higher). Nominal bond yields benefited from moderating inflation, the South African Reserve Bank (SARB) beginning its rate-cutting cycle and improving investor sentiment following the elections. Local cash allocations continued to deliver positive returns this quarter. Offshore bond and cash allocations contributed to performance on the back of the actions taken by the US Federal Reserve. The third quarter saw the first Fed rate cut in more than four years and global fixed income markets have reacted positively so far. However, the firmer rand acted as a headwind to the performance of offshore allocations. A small allocation to local listed property contributed to performance this quarter, benefitting from the recent positive sentiment, bringing its quarterly return to +18.7% and is the best-performing local asset class on a year-to-date basis. The fund's asset allocation is broadly similar to the previous quarter.

Fund Selection

The contribution from fund selection was mostly positive for the quarter.

Nedgroup Investments Global Emerging Markets Equity underperformed both its peers and the market this quarter. The fund's overweight positions in South Korea negatively impacted returns, with significant allocations to Samsung (-5.6%) and SK Hynix (-26.7%) delivering negative returns in hard currency. The fund's allocation to China and in particular Tencent (+10.9%), Alibaba (+35.0%) and Trip.com (+19.3%) added to the performance. However, this positive performance was insufficient to offset the negative returns. Furthermore, the strengthening rand over the quarter eroded returns, further detracting from the fund's overall weak performance.

PSG Equity delivered fourth quartile performance this quarter, despite delivering strong absolute returns. While the fund performed roughly in line with its composite benchmark of 80% FTSE/JSE Capped SWIX and 20% MSCI World Index, for the quarter, it lagged relative to its ASISA SA General Equity peer group. The fund's positions in domestic financials and industrials were contributors to performance over the quarter, with the main contributors being holdings in Discovery (+27.6%), Wilson Bayley Holmes-Ovcon (+44.5%) and Standard Bank (+18.5%). However, the fund's resources and foreign equity positions were detractors from performance this quarter. The main detractors were the fund's holdings of Northam Platinum (-13.8%), Noble Corp (-22.6%) and Shell Plc (-10.1%).

Ninety One Diversified Income delivered strong performance which was ahead of peers over the quarter. The fund benefitted from the strong rally in SA bonds over the quarter. The fund's overweight duration position contributed significantly to performance over the quarter, as medium and long dated SA bonds delivered strong returns. The fund also held an underweight position in offshore bonds over the quarter, which benefitted the fund as the rand strengthened significantly as a result of improved terms of trade and improved sentiment towards SA asset classes.

There were no changes made to the underlying funds in the portfolio in the third quarter.

Summary

We are pleased that the portfolio managed to generate a strong return over the third quarter, in a particularly strong local environment. The portfolio continues to be allocated to a diverse range of attractively priced local and global asset classes and we are confident that it will be able to deliver on its objective over the long term. The fund has adhered to its policy objective.

Glossary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

Fund Specific Risks
