

Fund Objective

The fund will, apart from assets in liquid form, consist solely of participatory interest in the approved, Sigma Select Global Leaders Fund under the Prescient Global Funds ICAV, an open ended umbrella fund with segregated liability between funds, domiciled in Ireland. The investment objective of the underlying fund is to outperform the Benchmark, as measured by the MSCI ACWI, over the long term. The underlying fund will seek to achieve its objective primarily through investing of up to 100% of its net assets in global equities which are listed or traded on Recognised Exchanges, or subject to the investment restrictions set out in the supplement.

Fund Strategy

The Fund capital is allocated to a carefully considered blend of independently managed global and specialist equity strategies.

The Fund is constructed by optimally blending the various manager styles and strategies to achieve the return target over the long-term.

A rigorous investment process underpins the identification and selection of managers according to their key strengths and specialisation.

These managers include the best active stock-pickers that the fund manager has encountered globally and they all have long term track-records of successfully generating superior returns for their investors.

Each manager is constantly assessed relative to their appropriate benchmarks and must consistently comply with the fund manager's stringent due diligence criteria.

The Fund exposure is constantly monitored and reviewed, and may be adjusted from time to time, having regard to the prevailing market conditions.

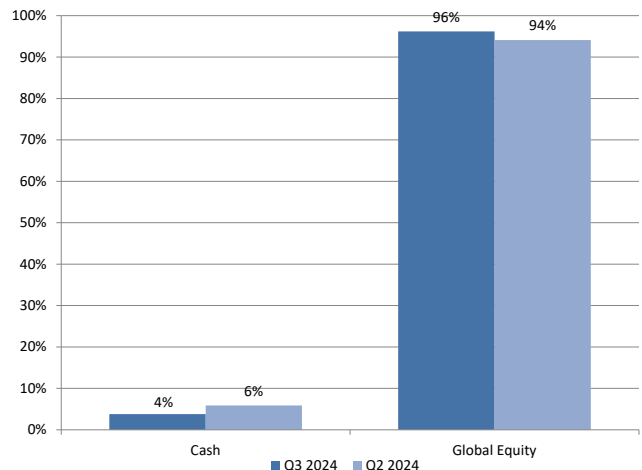

Quarterly Commentary - Q3 2024

Global equity markets concluded the third quarter on a positive trajectory, driven by shifts in monetary policy and renewed investor optimism, particularly in emerging markets. Despite heightened volatility, the MSCI All Country World Index (ACWI) gained +6.7% during the quarter, bringing the year-to-date return to +19.1% in US\$.

The Prescient Sigma Select Global Leaders Fund outperformed the MSCI ACWI during the quarter, achieving a +8.6% return. Notable contributors included the Prusik Asian Equity Income Fund, Contrarius Global Equity Fund, and Lyrical US Value Equity Fund, which posted returns of +15.6%, +14.0%, and +11.3%, respectively. The Sands Capital Global Growth Fund was the only fund to underperform the index, albeit still managing to deliver a positive return of +2.2%, all in US\$.

Inflationary pressures continued to ease across developed markets. In the U.S., headline inflation fell to 2.5% year-on-year in August, while core inflation held steady at 3.2%. In Europe, inflation approached the European Central Bank's (ECB) target, reaching a three-year low of 2.2%. Meanwhile, in the UK, inflation rose slightly to 2.2% after briefly aligning with the Bank of England's target in June.

The U.S. economy showed signs of slowing, with weaker employment data and declining manufacturing activity. The Manufacturing PMI fell to 47.9, indicating a deepening contraction, while non-farm payrolls added only 114,000 jobs in July, significantly below expectations. In the Eurozone, the September PMI dropped to 48.9, signalling ongoing economic weakness, while the UK remained in expansion territory at 51.5, demonstrating relative resilience.

As economic data softened and inflation moderated, monetary policy easing became a central theme, boosting investor sentiment. Federal Reserve Chair Jerome Powell signalled an imminent rate cut during his Jackson Hole speech, which materialised in September with a larger-than-expected 0.5% reduction. The ECB and Bank of England also cut rates during the quarter, contributing to a more favourable market environment.

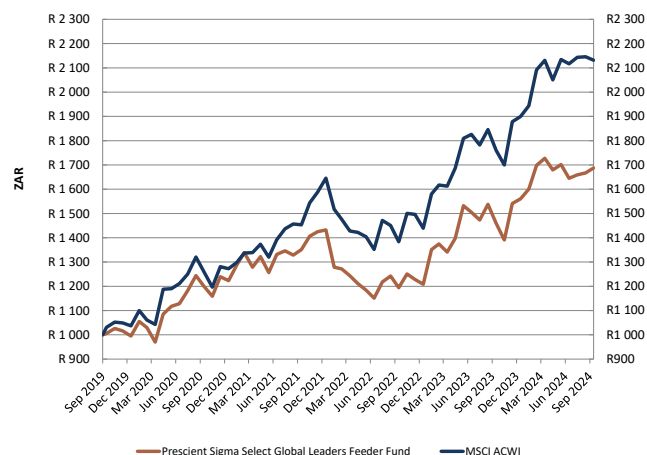
Emerging market equities posted strong returns gaining 8.9% in US\$ and outperforming developed markets. Chinese equities surged by +23.6%, driven by a coordinated stimulus package from policymakers that included both monetary easing and fiscal measures aimed at supporting the property sector.

Valuation disparities across sectors and regions within the MSCI ACWI remain significant. Large US technology companies continue to attract substantial capital flows, fuelled by optimism surrounding their advancements in artificial intelligence. This creates opportunities in neglected parts of the market that trade at more attractive valuations. For instance, prior to their significant re-rating in September, Chinese equities were trading on depressed valuations at less than 9 times earnings, despite having similar earnings growth prospects. This highlighting the value embedded in a neglected part of the market, particularly when investor pessimism has led to depressed valuations, and the subsequent upside when sentiment shifts.

Looking ahead, we believe that the Fund's selective exposure to undervalued and neglected parts of the market offers attractive return potential with a greater margin of safety, relative to the index. The Fund remains well diversified across regions, with an underweight to the U.S. equity market, particularly the large-cap technology companies.

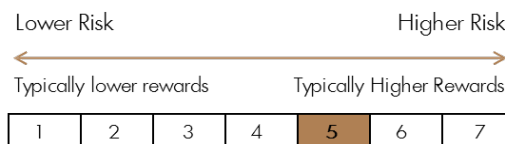
The portfolio has adhered to its policy objective as stated in the supplemental deed.

Fund Specific Risks

In addition to the risk captured by the indicator above, the overall Fund value may be considerably affected by:

- **Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Glossary Summary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest and Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio: The Sharpe Ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

%Positive Month: The percentage of months since inception where the fund has delivered positive return.

Volatility: Volatility is a statistical measure of the dispersion of returns for a given security or market index.

Feeder Fund: A Feeder Fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.
