## Strategy

The manager has a disciplined, fundamentals-driven bottom-up stock selection approach, with a focus on companies offering the best value relative to their long-term growth prospects, returns on capital and the quality of their management. When assessing a company, the manager uses regular visits to understand how each of these factors will change over time and to identify company-specific risks. In particular, the manager has a bias towards firms with a sustainable competitive advantage, particularly among small and medium sized companies where there are mispriced ideas available due to limited information amid lower market coverage.

## Objectives & Investment Policy

**Objective:** The fund aims to achieve capital growth over time. **Investment Policy:** The fund invests at least 70% (and normally 75%) of its assets, in equities of companies that are listed, headquartered, or do most of their business in equities of companies that are listed, headquartered, or do most of their business in the Asia Pacific region, including, but not limited to, Japan, Australia, China, Hong Kong, India, Indonesia, Korea, Malaysia, New Zealand, Philippines, Singapore, Taiwan and Thailand. Investment Process: In actively managing the fund, the Investment Manager considers growth and valuation metrics, company financials, return on capital, cash flows and growth and valuation metrics, company financials, return on capital, cash flows and other measures, as well as company management, industry economic conditions, and other factors. The Investment Manager considers ESG characteristics when assessing investment risks and opportunities. In determining ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. The fund aims to achieve an ESG score of its portfolio greater than that of its benchmark. Through the investment management process the Investment Manager aims to ensure that investee companies follow good governance practices. 

## Cumulative performance in USD (rebased to 100)


