



FUND COMMENTARY

November proved to be an eventful month for markets with both the Federal Open Market Committee (FOMC) and the Monetary Policy Committee cutting interest rates by 25bps and thrown into the mix was a Trump, Republican victory in the US elections. With our Prescient Economic Indicator (PEI) showing a re-acceleration of US growth, we have seen a less dovish pricing of the path for interest rates in the US. The market is now pricing in less than 3 interest rate cuts by the end of 2025. Locally we have seen a similar path, with market expecting less rate cuts than previously priced. This has resulted in a more elevated front end of the local yield curve, with the back end moving lower in yields performing well for the month.

The 12-month NCD rate moved lower by 17.5bps while 3month jibar continued to drift lower, moving 22.5bps as repurchase rate was also cut by 25bps in the month. Forward rate agreements (FRAs) are pricing just over 2 and half rate cuts over the next 12 months, compared with nearly five rate cuts at the end of September.

The Fund remains well positioned to fully capitalize on the current cycle, with our step rate note resetting at levels significantly above bank FRN spreads. Coupled with high-quality credit, this continues to enable the Fund to outperform its benchmark.

The Fund delivered a strong performance over the month, bolstered by positive yielding assets which contributed to the month's return.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.
