INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

INVESTMENT PROCESS

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Market Context

Equity markets delivered a mixed bag of returns largely attributed to a resounding victory for the Conservative Republican Party in the US elections. US stocks rallied as Donald Trump was voted into office and market participants positioned themselves for what has been promised to be an expansionary fiscal policy administration. This led Developed Markets higher as the MSCI World index closed the month up 4.59% while the S&P 500 index posted a solid 5.87% return for the month. The rest of the world was seemingly less enthusiastic about the prospect of an increasingly US-centric policy environment and the palpable threat of trade wars in what is still a dollar led global economy. Across the pond, The Euro Stoxx 600 index gave back 2.79% for the month as the earnings outlook for the region deteriorated. Further east, Japan and China similarly closed the month lower in hard currency in the wake of a rampant US dollar. The Nikkei 225 and CSI 300 indices gave back 0.55% and 1.13% respectively. The broader Emerging Markets were not spared as the MSCI EM index closed 3.59% lower. Our domestic market fell by 0.94%, predominantly because precious metal prices weighed on the Resources sector, which declined by 6.75%.

Fund Positioning

The Fund maintains the maximum effective exposure to the large and mid-cap sectors of the market. The top three sector allocations for this equity exposure were Financials, Basic Materials, and Technology, with largest share exposures to Naspers, FirstRand Bank and Standard Bank.

Outlook

Albeit still moderately positive, our outlook for the domestic equity market has shifted closer to strongly positive on the account of the softer market moves this month and heightening the valuation factor. This view is supported by strong consumer and business sentiment indicators, while restrictive monetary policy and high unemployment remain the largest detractors from our financial conditions and economic indicators.

Fund Performance

The Fund was down 0.50% in November, underperforming the benchmark, which fell 0.27%. YTD, the Fund is ahead of the benchmark by 3.88%, with a return of 16.88%.

Contributors and Detractors

The top contributors to the Fund's performance in November were British American Tobacco (+12.0%), Pepkor (+17.0%), and Anglo American (+4.6%). Detractors included Gold Fields (-11.7%), Naspers (-1.8%), and Harmony (-12.6%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
