The Fund invests in cash and high-quality capital market instruments. The Fund is structured to minimise the risk of not meeting the benchmark. Returns achieved above the benchmark are used in specialist strategies designed to enhance yield further.

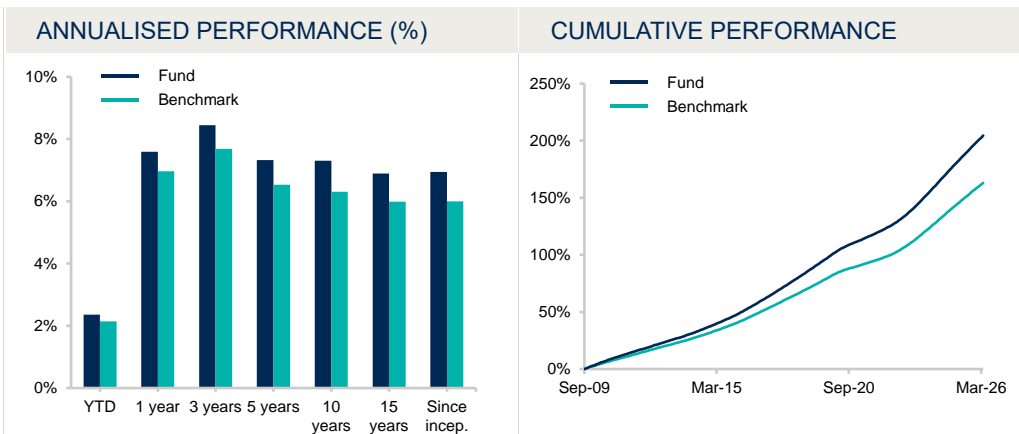
### WHO SHOULD INVEST

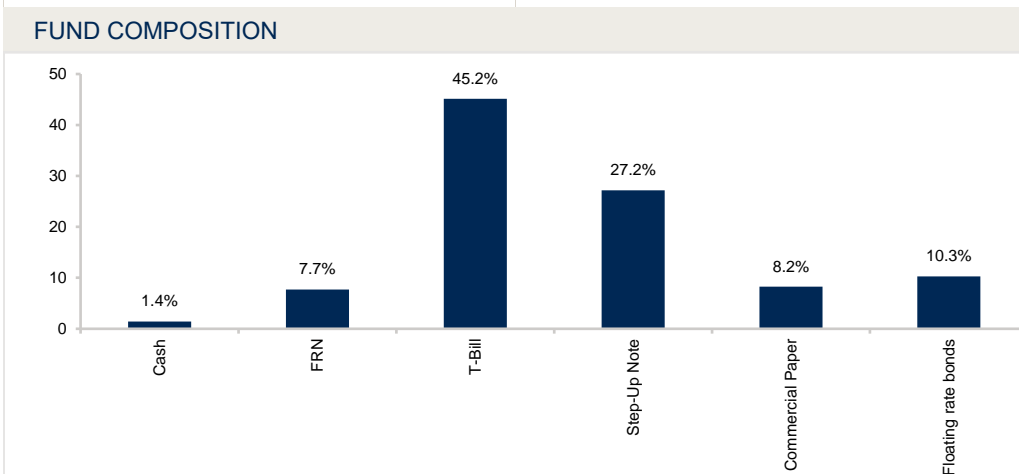
### RISK INDICATOR DEFINITION

## FUND COMMENTARY

Locally, in April 2026 SA money markets were dominated by a sharp upward turn of inflation and interest-rate outlook following the escalation of geopolitical tensions in the Middle East. The escalating surge in global oil prices interrupted the global disinflation trend and shifted the domestic rate expectations higher.

The South African Reserve Bank (SARB) maintained a cautious and hawkish tone throughout the month, however policymakers warned that fuel and imported inflation pressures were likely to intensify in coming months. The SARB reiterated that inflation is still expected to remain within the 3%–5% target band, but risks have become decisively skewed to the upside.

Money-market pricing materially adjusted upwards during April with expectations for additional rate cuts fading completely and portions of the forward-rate curve began pricing in the possibility of renewed tightening later in 2026.

Short-dated negotiable certificates of deposit (NCDs), Treasury bills, and call rates traded in a relatively elevated but stable range as liquidity conditions remained adequate. Front-end yields drifted higher during the month as investors demanded additional compensation for inflation uncertainty and geopolitical risk.

### Performance comment

Yields across the front-end money market universe such as treasury bills and high-quality bank instruments remained attractive, continuing to support income generation within portfolios making the Money market cash strategies very attractive in the current market conditions.

The Fund delivered strong performance in April, bolstered by positively yielding assets, which contributed to a meaningful overall return for the fund.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Interest rate risk:** The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

A Money Market portfolio is not a bank deposit account and the price is targeted at a constant value. The total return is made up of interest received and any gain or loss made on any particular instrument; and in most cases the return will have the effect of increasing or decreasing the daily yield, but in the case of abnormal losses it can have the effect of reducing the capital value of the portfolio. The yield is calculated as a weighted average yield of each underlying instrument in the portfolio. Excessive withdrawals from the portfolio may place the portfolio under liquidity pressures and a process of ring-fencing of withdrawal instructions and managed pay-outs over time may be followed. Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month.
