Strategy

The portfolio managers look to invest in quality companies at attractive prices. They identify them through various quantitative screens and in-house research and the conduct their own fundamental analysis. The quality characteristics they look for include sustainable high returns on capital that will enable the company to grow faster than competitors and generate high cash flows. ESG analysis is part of the investment decision making process alongside consideration of the quality and valuation of a business. When assessing investment ideas, the team establishes a "fair value" range for each stock on a cross-cycle basis and invest if the opportunity offers an attractive risk/ reward balance. 


