



**FUND OBJECTIVE & STRATEGY**

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

**MONTHLY COMMENTARY**

The ClucasGray Global Fund declined 1.9% in February as a sell-off in Software & Services stocks intensified during the month. The Morningstar Aggressive Allocation peer group, which carries a materially lower exposure to these sectors, returned +1.5%.

The market rotation out of US equities – particularly US technology companies – continued into February. The S&P500 declined 0.9%, while the tech-heavy Nasdaq fell 3.4%. European markets, which skew more towards value sectors such as Materials, Energy and Consumer Staples, benefitted from this rotation, with the Euro Stoxx 50 rising 2.7% and the UK's FTSE 100 surging 5.1%. Japanese equities (TOPIX +9.3%) continued to outperform western markets, buoyed by pro-growth fiscal policies.

On a sector basis, selling pressure mounted in Software & Services (-10.2%), bringing year-to-date losses to -20.8%. The market's concern stems from both the threat of direct AI competition and the uncertainty over what AI's impact on long-term workforce demand could mean for the sector's typical seat-based pricing model. Following a strong start to the year, Semiconductors (-0.6%) also retreated, despite extraordinarily strong growth reported by sector bellwether Nvidia. Meanwhile, Energy (+7.8%) and Materials (+9.4%) surged in line with commodity prices, while Consumer Staples (+7.7%) continued to attract equity flows on its defensive appeal.

The Fund's top-performing holding in February was pharmaceutical distributor McKesson Corp (+18.8%). The company continues to report robust growth, benefiting from strong volumes throughout the healthcare system. Euronext (+18.2%) also outperformed, as market volatility is expected to result in higher trading volumes and revenue. The Fund's worst-performing holding was Novo Nordisk (-37.0%), which gave back its recent gains after a trial for its next-generation obesity drug delivered disappointing results.

During the month, the Fund initiated a new position in the Global X Defense Tech ETF, gaining diversified exposure across major US and international defense contractors.

At month-end, the Fund had an underlying equity exposure of 99.3% and 0.7% in cash.








FUND ASSET ALLOCATION




NET CURRENCY EXPOSURE

## DISCLAIMER

During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
