INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve healthy real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - Low Equity funds over a full market cycle by maintaining moderate exposure to growth assets like equities.

INVESTMENT PROCESS

This Fund invests in local and offshore money market, bonds and inflation-linked bonds, property, preference and ordinary shares, derivatives and unlisted instruments to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation and exposure equities.

WHO SHOULD INVEST

Investors seeking real returns coupled with a stable and attractive income yield via significant exposure to the South African interest bearing markets. Although the Fund's mandate allows investment up to 40% in equities, it is expected to have lower actual exposure on average. This Fund is suitable to investors with a medium to long-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. These portfolios typically target returns in the region of 3% - 4% above inflation over the long term.

FUND COMMENTARY

In a surprising move, the Federal Reserve (Fed) initiated its rate-cutting cycle by lowering rates by 50 basis points in September. This decision came as a shock to many market participants, who had anticipated a more conservative cut of 0.25 percentage points. The more aggressive rate cut reflects the Fed's concern about economic conditions, particularly the slowing labour market. US inflation dropped to 2.2% from 2.5% in July, signalling progress toward the 2% target and supporting accommodative policy.

In South Africa, the Reserve Bank's Monetary Policy Committee (MPC) recently decided to cut the repo rate by 25 basis points, a move that was not surprising to bond investors and has sparked discussions about the current economic climate. As expected, the 10-year benchmark yields across advanced economies dropped. The nominal bond space saw both the R2030 and R2048 yields drop by 36 and 54 basis points respectively. The equity market also had an overall positive response to the repo rate cut as most major indices increased with the JSE All Share Index rising by 4.04%. This uptick can be interpreted as a sign of market optimism, suggesting that investors are hopeful for an economic rebound.

The Fund currently favours an underweight towards developed and emerging market equity, while having a neutral allocation towards SA bonds and equity.

The Fund performed strongly over the course of the month, largely due to strong local rallies in local equity (+3.28%) and nominal bonds (+3.86%) as well as emerging markets (+6.68%) and developed market equity (+1.83%). The fund also benefited from the rand hedges it has in place as the Rand appreciated from 17.81 in August to 17.21 at the end of September.

Recent trends in reduced inflation in South Africa are likely to continue, especially with lower oil prices and a stronger currency feeding through into lower inflation figures. As such this gives room for the SA reserve Bank to implement further cuts to the reserve rate towards the end of the year which would be supportive for local equity and bond markets.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.
