### / Portfolio description

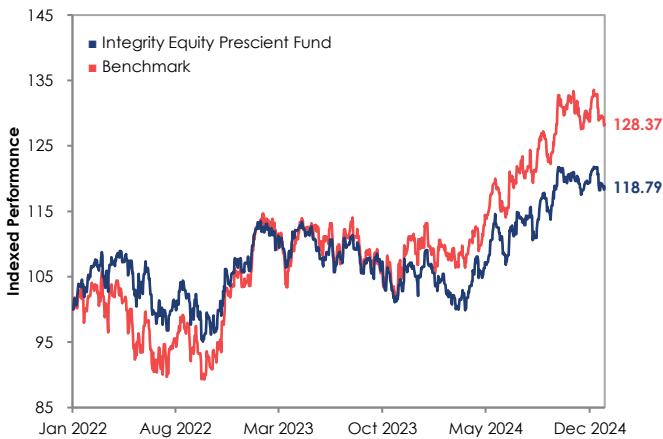
The primary objective of the portfolio is to achieve long term capital appreciation by investing in a diversified portfolio of **South African listed equities**. The portfolio manager acquires local equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of worldwide economic, sector and investment trends to tilt the portfolio towards attractive sectors and companies.

The Integrity Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a **value investment philosophy and process**. This is the same investment philosophy and process applied in managing the Integrity Local Equity Strategy, with track record since 5 August 2011.

The portfolio has adhered to its policy objective since its inception.

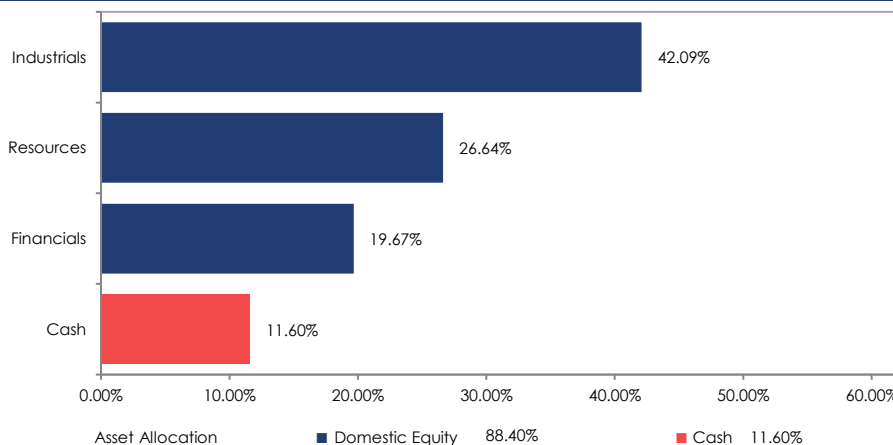

### / Sector allocation



### / Relative performance

Over the quarter, the fund generated a negative return of 1.94% compared to the FTSE/JSE All Share Index's total return of -2.13%. The Fund benefited from its top performing shares over the period, namely; Telkom, Cashbuild, Hudaco Industries and The Spar Group. Conversely, the largest contributor to the negative return for the Fund was the exposure to Sasol which resulted in a negative contribution to return of 1.27%. Additionally, the Fund's exposure to AB InBev, Sibanye-Stillwater and Trelidor detracted from the Fund's performance. Being underweight to certain SA banks, namely; Firststrand, Nedbank, and Standard Bank, contributed to the Fund's alpha over the period. This led to a positive contribution to return of 0.92%. Over the quarter, a continued tilt from value to growth was experienced, as the FTSE/JSE Growth Total Return Index decreased by 1.92% compared to a decrease of 2.39% in the FTSE/JSE Value Total Return Index. Considering the current macro backdrop, the Investment Manager expects value outperformance to reassert itself in the future once market participants' irrational exuberance is challenged and fundamentals, once again, start to count again.

### / Fund composition

Over the quarter, the Investment Manager decreased exposure to certain shares that performed well, namely; ABSA Group, Telkom, Impala Platinum, The Spar Group, and Netcare. The Fund increased exposure to Anglogold Ashanti, Sasol, AB InBev, and Cashbuild. The Investment Manager initiated exposure to Astoria Investments and the Ashburton Stable Income Fund over the period. Additionally, a derivative protective put strategy was initiated for the Fund's exposure to Sasol during the quarter. The above portfolio changes resulted in an increase in cash exposure from 11.20% to 11.60%. The Fund's Resources allocation decreased from 27.24% to 26.64%, Industrials allocation increased from 41.33% to 42.09%, and the Financials allocation decreased from 20.22% to 19.67%.

### / Glossary

**Annualised performance:** Annualised performance shows longer-term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The Net Asset Value represents the assets of a Fund less its liabilities.

**Risk profile:** A measure of the volatility of the fund and volatility is a statistical measure of the dispersion of returns for a given security. Low risk portfolios indicates less volatility with potentially lower returns and high risk portfolios indicates more volatility with potentially higher returns. High risk portfolios generally hold more equity exposure than any other risk portfolios and therefore tend to carry higher volatility.

### / Risk
