#### **Fund objective**

Abax SA Balanced Prescient Fund is a domestic fund with a mandate to invest across a wide range of South African asset classes. The Fund is suitable for retirement savings and complies with Regulation28.

The Fund's primary objective is to outperform the peergroup (as measured by the ASISA South African MA SA Equity Category Average) on a net fee basis over the medium term.

The Fund has a moderate to high risk profile and is suitable for investors seeking long-term capital growth and moderate levels of income, who can tolerate the associated high levels of capital volatility. The Fund is not permitted to invest in offshore investment markets.


