

## STONEHAGE FLEMING GLOBAL SELECT EQUITY FUND

#### INVESTMENT OBJECTIVE

To achieve capital growth over the longer term by investing in a blend of collective investment schemes which either have a sustainable investment objective or promote environmental and/or social characteristics. The fund has adhered to its policy objective as stated in the Supplement.

#### INVESTMENT POLICY

In seeking to achieve its investment objective, the Fund will invest predominantly in a range of underlying collective investment schemes (the "Underlying Funds" which comply with the Central Bank's requirements as regards investment by a UCITS in other collective investment schemes and where such Underlying Funds provide exposure to a portfolio of assets comprising mostly global equities and equity related securities (which may be listed or traded on Recognised Exchanges or unlisted) and cash.

Such Underlying Funds may also provide exposure to other elements, being bonds (including corporate debt securities and bonds issued by sovereign, supranational entities and/or corporate issuers rated investment grade at time of purchase from either Moody's or another generally recognised international rating agency), non-investment grade debt, emerging markets, and infrastructure exposure (e.g. solar and wind power generation), subject to and in accordance with the investment restrictions set out in the Prospectus.

#### COMMENTARY

The Fund posted positive returns in Q4 as global economic data and company earnings remained resilient. Healthcare equities delivered a standout quarter after the U.S. administration reached an agreement with several healthcare companies on most-favoured-nation (MFN) pricing - a development viewed as a win for both sides and a positive contributor to Fund performance.

Schroder Sustainable Growth was the best performing strategy over the period. One of the key drivers of performance was AstraZeneca; the company has seen good growth in its cancer drugs and its rare disease segment is performing well. Banco Bilbao Vizcaya Argentaria (BBVA), a Spanish bank with significant sustainable commitments, saw strong growth and was another contributor to performance. The softer performers in the quarter included the environmental strategies, Impax and Pictet.

During the quarter, Evenlode Global Income and Impax Environmental were sold, and replaced by Evenlode Global Opportunities and Nordea Global Climate. In both instances, we believe the responsible investment credentials of the substitutions are similarly robust, whilst investment returns are expected to be higher with lower costs.

#### INVESTOR PROFILE

The Fund is appropriate for all investor types, including those with only a basic knowledge of funds. It is compatible with investors who do not need a capital guarantee (investors must be prepared to accept fluctuations in the value of capital, including the ability to bear 100% capital loss) and are looking for capital growth.

Due to the volatility of markets, investors should be willing to accept price fluctuations in exchange for the opportunity of potentially higher returns. This is a long-term investment and investors should have an investment time horizon of at least 5 years. The recommended holding period does not provide any guarantee that the objective will be achieved. This product is eligible for all distribution channels (e.g. investment advice, portfolio management, non-advised sales and pure execution services).

The Fund is unlikely to be appropriate for those who:

## RISK AND REWARD PROFILE
