

Portfolio composition

During the quarter the fund disinvested from Vunani Bond Fund and cash. The proceeds were allocated to Satrix Bond and 10x Yield select bond fund, given that the interest rates will be coming down.

Monthly market commentary

South African bonds delivered strong returns for the quarter, with the FTSE/JSE All Bond Index (ALBI) gaining 10.54%. The formation of the Government of National Unity (GNU) boosted post-election market sentiment, driving a bond rally as increased political stability enhanced investor confidence. A standout performer in the portfolio was the Discovery Strategic Bond Fund, which outperformed the ALBI by 0.37%. Additionally, the 10X Yield Select Bond Fund had a strong quarter, returning 12.33%.

In contrast, inflation-linked bonds struggled to keep pace with nominal bonds, with the 1nvest ILB Index Tracker returning just 4.89% during the same period. As a result, the decision to maintain an underweight position in inflation-linked bonds contributed positively to the fund's overall relative performance. This strategic positioning allowed the portfolio to capitalize on stronger nominal bond returns, reflecting a favourable market environment for fixed-income investments during the quarter.

Yields

The yield for bond and income portfolios is historic and is calculated quarterly.

Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. The ability of the portfolio to repurchase is dependent upon the liquidity of the securities and cash of the portfolio. Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation point defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax.

The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. Illustrative investment performance is for illustrative purposes only.

Glossary

• Drawdown

Annualised - An annualised return is the weighted average compound growth rate over the period measured.

Volatility - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

Maximum drawdown - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

Sharpe ratio - The sharpe ratio is a measure of risk-adjusted returns. The sharpe ratio reflectes the extent to which an investment compensates for extra risk.

What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the TER and TC.
