

GENERAL INFORMATION

Collective Investment Schemes in Securities (CIS) should be considered as medium to longterm investments. TOTAL EXPENSE RATIO (TER)

The Fund's Total Expense Ratio (TER) reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. TRANSACTION COSTS (TC)

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

TOTAL INVESTMENT CHARGE

The sum of the TER and TC is shown as the Total Investment Charge. Since Fund returns are quoted after the deduction of these expenses, the TER and TC should not be deducted again from published returns.

GLOSSARY SUMMARY

Performance: Performance has been calculated using NAV to NAV with income reinvested. The performance for each period shown reflects the return for investors who have been fully invested for that period. Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Moderate: Generally, these portfolios hold more equity and offshore exposure than lower risk portfolios / less than higher risk portfolios and therefore tend to exhibit higher / lower variability in returns (volatility). While expected returns could be higher than lower risk portfolios, the potential loss of capital could also be higher.

FUND SPECIFIC RISKS
