The investment objective of the Fund is to provide investors with capital appreciation and to generate income over the medium to long term through exposure to international real estate assets.


Risk Indicator Definition


RISK INDICATOR





MARKET COMMENTARY

In January, the fund outperformed the benchmark by 240bps, as it was up 6.15% while the benchmark was up 3.75%. The outperformance was mainly driven by the third bite of the apple, namely stock selection, which contributed 176bps, while the first and second bites of the apple, namely region and sector allocation, increased performance by 70bps. We held around 7% cash, which is higher than usual on the back of higher-than-usual market volatility, resulting in a negative 6bps performance due to currency movements. Equity markets had a good start to the year, although that tapered off towards the end of the month as geopolitical tension and further discussions on tariffs and trade caused uncertainty. The Developed Property Index outperformed most of the developed market indices but underperformed South African equities and the Emerging Property Index.

The best-performing region this month was HK, with the developers up 23% and the REITs up 3%. We are overweight HK, specifically developers, as valuations are attractive and home prices have turned the corner. Singapore was the second-best performer, with the developers up 19% and the REITs up 2%. We remain marginally underweight Singapore as valuations are full and the Singapore government is likely to step in to calm the market at some point. The UK was in third place, up 7% for the month, and we remain overweight the region as we expect prime office rentals to continue higher given strong leasing demand. Japanese REITs were the weakest performers, flat for the month, and we remain neutral. We remain underweight Australia, the second weakest region, up only 2%, as high inflation leads to increasing interest rates. Lastly, we are heavily underweight the US, which was up only 3% for the month. Broadly speaking, we are likely to take some profit in Hong Kong, where valuations have moved to fair, and shrink our underweight in the US, where falling interest rates are more likely given the weak labour market recently and the new Fed chair later in the year.

The US sector that performed best for the month was net leases, up 9%, where we are overweight, as valuations and fundamentals are attractive. Data centres were second, up 7% on the back of strong demand from AI, but we remain underweight given the incredible supply pipeline from non-property companies. Storage was third, up 6%, where we remain underweight given weak fundamentals on the back of a static residential property market. At the opposite end of the spectrum, the weakest performer was offices, down 2%, where we had no exposure for most of the month, although we added BXP at the end of January. Residential, our most underweight sector, fell 1% as fundamentals remain weak on the back of poor affordability metrics. We are currently focused on US part of the portfolio and will scour the results released over the coming weeks for clues to changes in sector fundamentals.

The best-performing stock in our portfolio for the month was HK developer New World Development, up 56%, as potential asset sales, a stronger Hong Kong residential market and other news buoyed the stock. UK office stock Derwent was in second place, up 13%, as prime London office rents continue to climb. US life science stock Alexandria Real Estate was third, up 12%, bouncing from extremely attractive valuations after the stock price rout of 2H25. At the opposite end of the spectrum, the weakest performing stocks were all down 4%. They were US office stock BXP, which was added at the end of the month, US single-family rental stock Invitation Homes, which suffered with the other US residential names, and EU office stock Colonial, which is struggling to gain traction amongst investors.

The year has started on a good note for real estate stocks, as they outperformed other developed market equities. We prefer the EU and Asia over the US, as valuations and fundamentals should benefit the former group. We are currently assessing the 4Q25 results and reviewing our sector weightings in the US and are likely to adjust our portfolio accordingly to best position ourselves for the year ahead.

Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
