FUND OBJECTIVE AND PHILOSOPHY

The investment objective of the Baymont Global Equity Fund is to achieve long-term capital growth by investing across global equity markets. The investment philosophy is to invest in dominant, high-quality businesses which have a history of developing both growth and real economic value. The fund has adhered to its policy objective.

FUND MANAGER COMMENTARY

Robust economic growth, with moderating inflation and a solid labour market set the scene for a strong equity market. Developed markets up 2.2% and Emerging Markets up 3.9%. The Magnificent 7 (Alphabet, Amazon, Apple, Meta, Microsoft, Nvidia and Tesla) contributing half of the MSCI World's performance for the year so far. Nvidia, up 150% year to date is the standout performer. Emerging markets showing a good recovery, with significant impact from TSMC (Taiwanese chipmaker).

Apart from a few exceptions, rates continue to remain on hold as inflation rates moderates slowly. Rate cuts consistently being pushed out further. The geopolitical environment remains elevated. For an election year in so many countries, politics will impact on sentiment in the short-term. Cash and bond yields are attractive and will be competing for a place in portfolios that were previously equity heavy, especially as equity valuations are creeping up.

After a poor first quarter, Apple made a strong recovery and was a key contributor to the performance of the fund in the second quarter, as well as Alphabet and Novo Nordisk. The key detractors to LVMH and Waters Corp. A few changes were made to the fund, based on pricing, diversification and risk characteristics. We added Diageo, Charles Schwab and Royal Dutch Shell. To fund these purchases we sold Alibaba, Roche, UBS and Honeywell.

We will stay focused on attractively priced companies with a robust competitive advantage, strong balance sheets and low sensitivity to economic cyclicality. We remain patient investors and assess the opportunities as they present themselves.

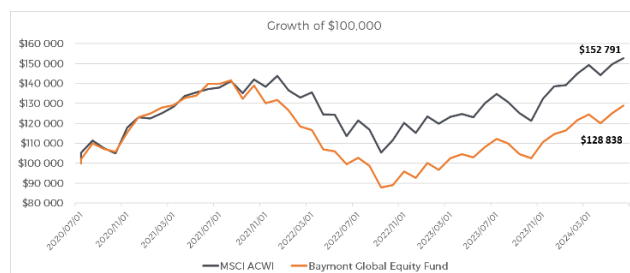

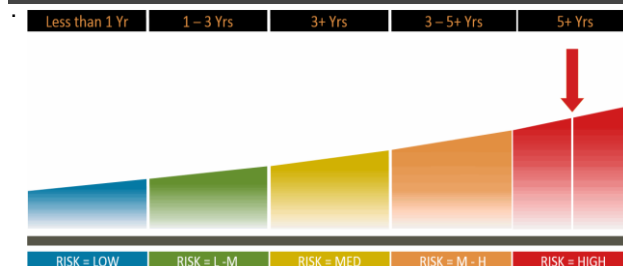

Growth of \$100 000 investment net of all fees and expenses



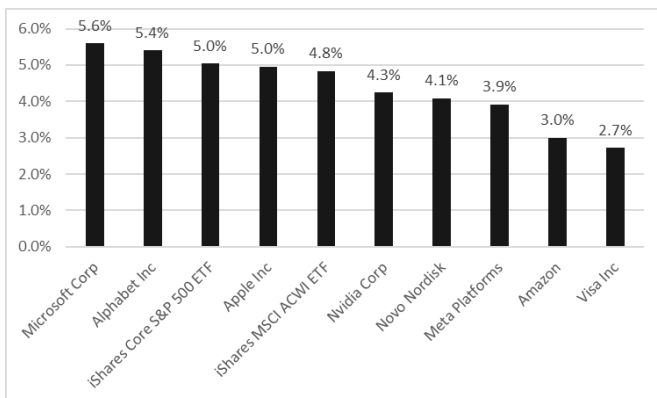
RISK PROFILE



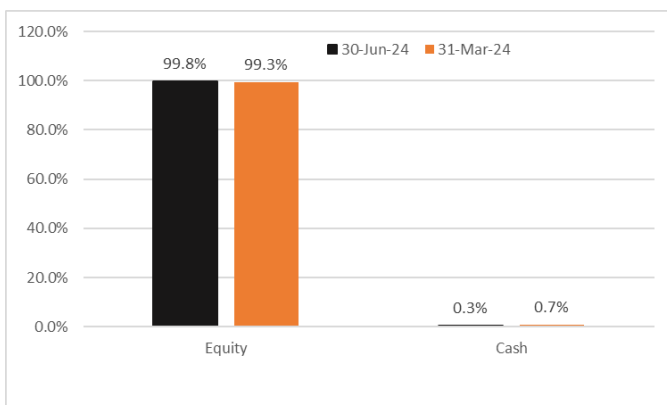

GLOSSARY

Net Asset Value (NAV): means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.

Annualised Performance show longer term performance rescaled to a one-year period. Annualised performance is the average return per one year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Return: The highest and lowest rolling twelve-month performance of the portfolio since inception.

Total Expense Ratio (TER): reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.

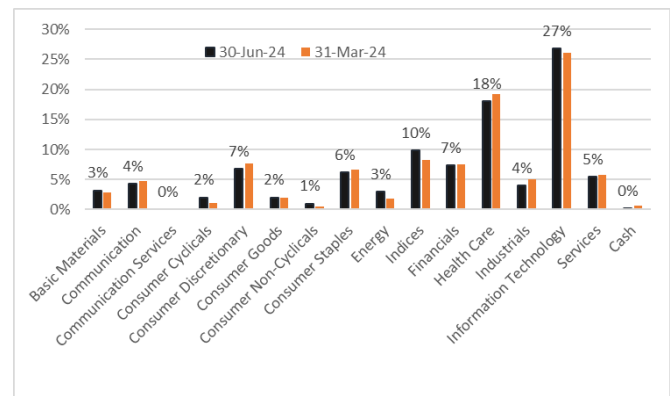
Transaction Costs (TC): is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.

Total Investment Charge (TIC) should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.

Total Investment Charges (TIC%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

FUND RISK

Derivative Risk: Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.

Volatility Risk: Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.

Concentration and Sector Risk: A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will materially impact the returns of the portfolio more so than diversified portfolios.

Equity Risk: Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.
