Investor Profile

The Fund is suitable for investors with a longer-term investment horizon, seeking real capital growth, coupled with regular income distributions that are sourced on a worldwide basis. The Fund is an attractive addition to the overall income being generated on an asset base of domestic investors.



Investment Objective and Strategy

The objective of the Fund is to provide investors with real capital and income growth, in excess of South African consumer inflation +3% per annum, over rolling 3-year periods.

The Fund will aim to not exceed 80% exposure to equities on a worldwide basis, while sourcing an increasing income stream in multiple currencies and geographies.

The Fund will invest in a diversified mix of higher quality worldwide assets, including equities, bonds, property, cash, preference shares, collective investment schemes and other instruments as determined by the Authority from time to time that conform with the Fund objectives.

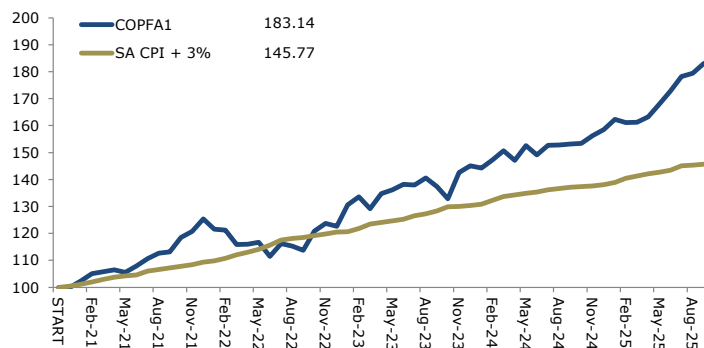

Value of R100 invested at inception, income reinvested, NAV-NAV



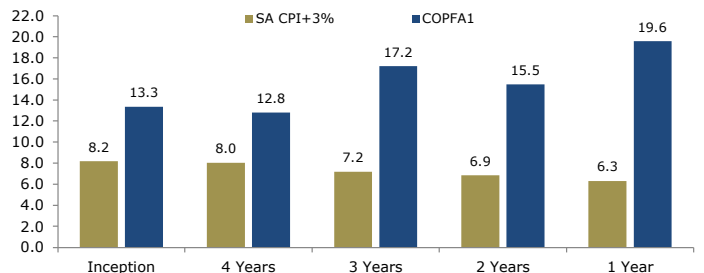

The Fund's **Total Expense Ratio (TER)** reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. Glossary

Annualised performance:

An annualized total return is the geometric average amount of money earned by an investment each year over a given time period. It is calculated as a geometric average to show what an investor would earn over a period of time if the annual return was compounded.

NAV:

The Net Asset Value (NAV) represents the assets of the Fund less its liabilities.

Highest / Lowest 1 year return:

These figures represent the highest and lowest rolling 12-month returns on each unit class of the Fund since inception.

Higher Risk Portfolios:

Generally, these portfolios hold more equity and offshore exposure than either lower or medium risk portfolios and therefore tend to exhibit higher variability in returns (volatility). While expected returns could be higher than lower or medium risk portfolios, the potential loss of capital could also be higher.

Activity during the quarter

While not appearing in our Top 10 holdings at quarter-end SA bond exposure was reduced via our allocation to the Coronation Bond and PIM Flexible Bond Funds after stellar returns of late. Capital was added domestically to existing allocations in miners (Glencore, Northam Platinum and AngloGold) and banks (ABSA and Standard Bank). With the Investec Preference share trading above par the holding was sold. Offshore, reductions in Citigroup and JCI (valuation concerns), sales of PayPal and Adobe (opaque growth catalysts) were offset by the introduction of Alibaba (attractive valuation and cheaper AI entry point).

Contributions to Fund quarterly return

As expected from a stock, asset class and geographically diversified portfolio, the source of both contributors to and detractors from absolute returns was diverse. SA equity (specifically precious metals) and bond exposure performed well during the period. Those stocks without a very clear AI growth trajectory (Salesforce), catalyst (PayPal) or linked to economic growth (Anheuser) lagged during the period.

Changes in asset allocation

Outside of the bond exposure change mentioned above, there have been no material changes in exposure to risk assets or geographic orientation. The exposure to risk (Equity, Real Estate & Preference) assets remained compliant with maximum equity exposure guidelines of 80% at 77.2%. While increases in SA listed mining stocks increases SA exposure optically at quarter-end, the geographic earnings profile of the Fund is unchanged.

A note on portfolio risk

Drawdown measures the peak-to-trough decline during a specific period, quoted as a percentage between the latest peak and subsequent trough of the Fund, before a new peak is achieved. It is instructive when measuring the loss to the portfolio during a period and the subsequent return required to return to the previous peak of the portfolio. The drawdown profile shown alongside depicts the increased volatility being experienced in risk markets since inception. Asset allocation intervention during such periods is necessary to compress the recovery time factor and/or limit further downside. The appropriate period over which to measure performance of the Fund is rolling 5-year periods, given the risk profile and recommended holding period. Shorter measurement periods are linked to a higher variance in returns (see table below left)

Adherence to Fund Policy Objective

The Fund has adhered to its Policy Objective, as stated in the Supplemental Deed, in all respects during the quarter. There are no unresolved breaches to report from prior periods.
