### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to outperform both JSE All Bond Index and the STeFI Call Index over time, utilising active bond and cash management combined with strategies which aim to reduce risk over time.

### INVESTMENT PROCESS

The Fund invests in cash and high-quality capital market instruments. A number of techniques are used to generate returns, including duration management, yield enhancements via credit exposure and risk management strategies, where these strategies are designed to provide downside protection.

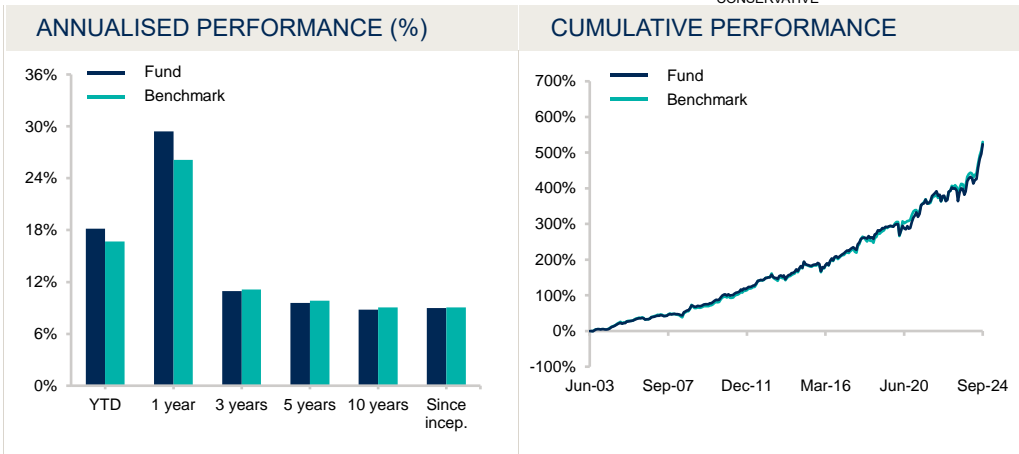
### WHO SHOULD INVEST

Investors requiring a specific allocation to the bond market but is prepared to give the fund manager some discretion to exercise his views on value in the bond market. This Fund is Reg. 28 compliant.

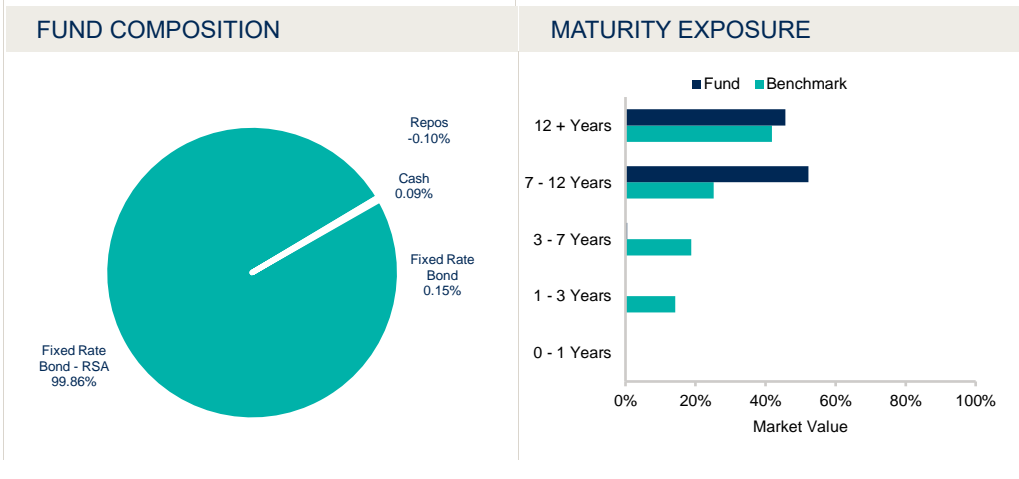
### RISK INDICATOR DEFINITION

This portfolio can invest across the duration spectrum from money market to long bonds, which can result in capital volatility over the shorter term and deviation from the benchmark. It is managed in such a manner that the probability of capital losses over one-year periods is unlikely. This portfolio typically targets a return in the region of 2% - 3% above inflation before tax over the long term.

## FUND COMMENTARY

### Market Context

In September, both the FOMC and the MPC cut rates, with the FOMC lowering rates by 50 basis points and the MPC by 25 basis points. While the excitement surrounding the Fed's dovish initial cut was somewhat tempered by Chairman Powell's cautious commentary and the committee's forward projections, the potential for data and monetary policy surprises remains high. The MPC's decision to cut the repo rate by 25 basis points was unanimous. Their assessment of the inflation outlook is considered balanced, and they now forecast a modest undershoot of the 4.5% target midpoint for both headline and core inflation in 2025 and 2026.

### Fund Positioning

We currently favour the belly area of the curve. This is primarily held through R2032s and R2037s, which represent 75% of our portfolio.

### Fund Performance

The Fund outperformed its benchmark during the month and currently offers a gross yield of 10.03% p.a., compared to 9.74% p.a. for the All Bond Index.

### Contributors and Detractors

The local nominal bond market saw a 3.86% increase on a total return basis for September, with the 12+ year segment of the curve outperforming. The inflation-linked bond market also posted gains, rising by 0.7% over the month.

The best-performing nominal and inflation-linked bonds were the R214 and I2046, returning 5.85% and 1.24%, respectively.

### Outlook

South African bond yields continue to respond to pricing impulses from geopolitical developments, central bank actions, and their consequent effects on global financial conditions. For some emerging economies, high risk-free policy rates, combined with a strong dollar and weaker demand from advanced economies, could increase capital outflow pressures—particularly for commodity importers facing higher commodity prices and weaker exchange rates.

These pressures pose challenges, especially for borrowers with currency mismatches between their assets and liabilities, creating a significant "risk-off" environment.

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.

**Forward Yield:** The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

**Interest rate risk:** The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

**Derivative counterparty risk:** A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.
