ABOUT THE FUND

The Fund is actively managed on a discretionary basis to provide stable long-term growth with moderate level of risk. The Fund shall be within 2 years of the modified duration of the BEASSA Total Return Index.

INVESTMENT STRATEGY

The Fund aims to deliver a return in excess of the benchmark over the long term, which comprises a reasonable level of income, as well as capital performance relative to the benchmark. The portfolio will invest in interest bearing and non-equity securities (including, but not limited to, government or quasigovernment bonds, corporate bonds, cash deposits, money market and other interest-bearing securities), as well as listed and unlisted financial instruments in line with appropriate regulations. The investments are actively managed and will change over time to reflect a macro fundamental outlook including the interest rate cycle, business cycle, default cycle, as well as other cyclical and credit factors.

The portfolio has adhered to its investment objective and there were no material changes to the composition of the portfolio during the reporting period.










FUND COMMENTARY

The Umthombo Wealth Institutional Active Bond Prescient Fund outperformed the ALBI (benchmark) as the South Africa sovereign yield curve effectively bull flatten, and break-evens narrowed. Following a drift higher given some local profit taking, the bid came back in SAGBs as the month end flows got going with SA set to get inflows and the new bonds going into the index, from an initial outflow.

Although the results of the US elections spurred a strong bout of initial USD strength, the rally has started to lose steam now that global concerns around tariffs and geopolitical conflict are easing. South Africa's SARB govt bond holdings rose to ZAR36.425b in November from ZAR35.304b in October, according to the South African Reserve Bank. Bonds remain constructive on the back of foreign buying and historically bonds have traded well over this December holiday period as auction supply reduces and R186 coupon payments take place.

GLOSSARY
