### Fund objective

Abax SA Balanced Prescient Fund is a domestic fund with a mandate to invest across a wide range of South African asset classes. The Fund is suitable for retirement savings and complies with Regulation 28.

The Fund's primary objective is to outperform the peer group (as measured by the ASISA South African MA SA High Equity Category Average) on a net fee basis over the medium term.

The Fund has a moderate to high risk profile and is suitable for investors seeking long-term capital growth and moderate levels of income, who can tolerate the associated high levels of capital volatility. The Fund is not permitted to invest in offshore investment markets.

The Fund will have an effective equity exposure of up to 75% and a maximum effective property exposure of up to 25% of the market value of the portfolio.

### About the Fund

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection.

The Fund is managed by Matthew de Wet and Lebeko Shai.

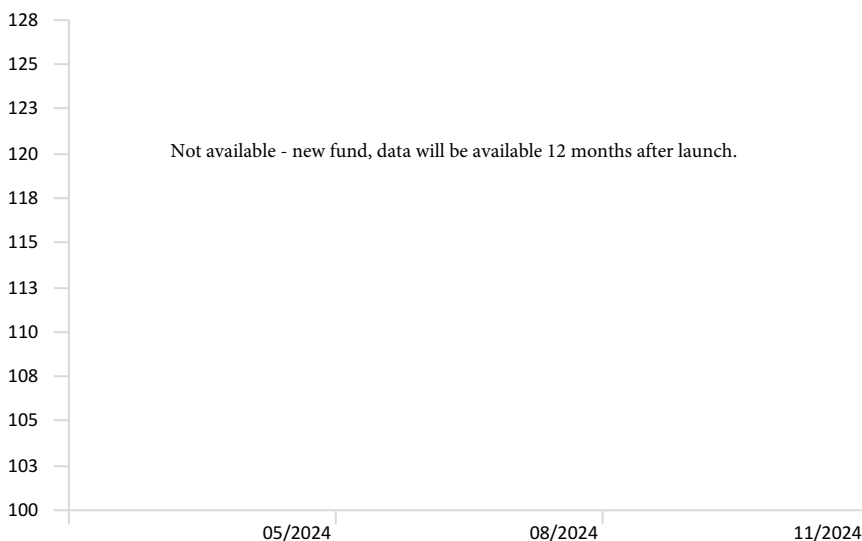

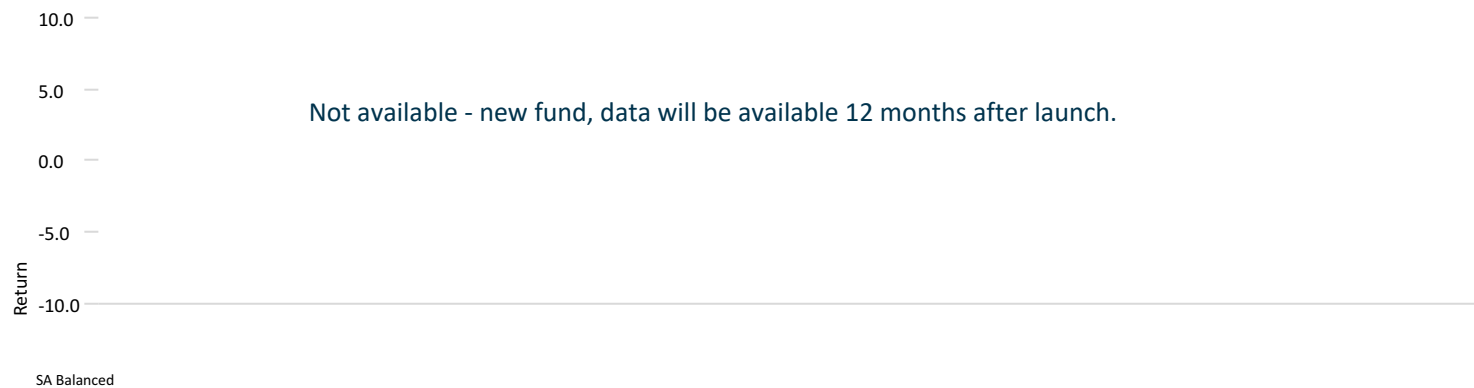

NAV - The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio - The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation - The deviation of the return stream relative to its own average.

Max Drawdown - The maximum peak to trough loss suffered by the Fund since inception.
