Abax Diversified Income Prescient Fund is a domestic fund with a flexible mandate to invest across a wide range of local and offshore fixed income asset classes.


The Fund's primary objective is to outperform cash, as represented by 110% of the STeFI Call Index, with a high degree of capital stability.


