

Portfolio composition

There have been no material changes to the composition of the fund over the last quarter.

Monthly market commentary

January saw a rebound from December's negative equity returns, while yield markets exhibited mixed performances. In equities, developed markets retuned 3.8%, with US and Eurozone equities delivering returns of 3.5% and 7.1%, respectively. Japan however, posted a negative return of 0.3% during the month. Emerging market equities advanced 1.9%. In fixed income markets, developed markets saw modest gains, with US Treasuries and UK Gilts both yielding 0.6%. German Bunds fared worse, delivering a negative return of 0.8%. In currencies, the US dollar has strengthened against Euro by 0.7% while it also weakened against the Sterling by 0.9%. 2025 began amid geopolitical tensions, trade disputes and different monetary policies by major central banks. The US headline Consumer Price Index (CPI) report showed a slight uptick from 3.15% to 3.16 in December, while core inflation was reported at 3.20%. The Federal Reserve took a cautious stance and maintained the target range for the federal funds rate at 4.25-4.5%. In Europe the final core and headline CPI figures for January came in at 1.27% and 2.70%, respectively. The European Central Bank lowered their key rates by 25bps, bringing the deposit facility rate to 2.75%. The UK reported its December inflation at 1.36%, up from 1.35% in the prior month. Core CPI stood at 3.20%. The Bank of England held no meeting in January. Similarly, Japan's inflation also ticked up, reporting a year-on-year December inflation of 1.11%, up from 1.10% in November. The Bank of Japan decided to raise its interest rates by 25bps. From a yield perspective, markets generally saw yields rising across the board. The US 10-year fell from 4.57% to 4.55% and the 2-year decreased from 4.24% to 4.20%. Germany's 10-year yield increased from 2.36% to 2.46% and the 2-year increased from 2.09% to 2.12%. In the UK, the yield on 10-year and 2-year Gilts both decreased from 4.57% to 4.54% and 4.38% to 4.22%, respectively. European high yield debt (returned 0.4%) underperformed relative to its US equivalent (returned 1.4%), whilst emerging market debt returned positively, 2.0% in local currency terms.

Yields

The yield for bond and income portfolios is historic and is calculated quarterly.

Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. The ability of the portfolio to repurchase is dependent upon the liquidity of the securities and cash of the portfolio. A manager may suspend repurchases for a period, subject to regulatory approval, to await liquidity, and the manager must keep the investors informed about these circumstances.

A feeder fund is a portfolio that invests in a single portfolio of a collective investment scheme which levies its own charges, and which could result in a higher fee structure for the feeder fund.

Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation point defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax. The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. Glossary

Annualised return - An annualised return is the weighted average compound growth rate over the period measured.

Highest & Lowest return - The highest and lowest returns for any one year over the period since inception have been shown.

Volatility - Volatility (also called standard deviation) is a measure of how widely the returns varied over the period measured.

Maximum drawdown - A maximum drawdown is the maximum loss from a peak to trough of the portfolio over the period measured, before a new peak is attained.

Sharpe ratio - The sharpe ratio is a measure of risk-adjusted returns. The sharpe ratio reflectes the extent to which an investment compensates for extra risk.

NAV - The net asset value represents the assets of a fund less its liabilities.

What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the investment of the portfolio. It is the sum of the TER and TC.
