



Income Distribution:



MARKET COMMENTARY

The MSCI ACWI Index gained 2.96%, the Netherlands and Australia were the strongest performers, rising 14.9% and 6.6% respectively, while Switzerland saw a decline of 0.2%. The MSCI Emerging Markets Index rose 8.85% over the month. Within emerging markets, South Korea and Turkey posted strong gains of 25.9% and 23.7%, while India and Indonesia were the main detractors, declining 5.1% and 5.6% respectively (all figures in USD).

US equities edged higher in January, with markets rising 1.27%, as investors digested steady inflation data alongside further signs of slowing labour market momentum. Inflation figures released during the month showed headline CPI rising 2.7% year on year in December, while core inflation remained contained at 2.6%. US companies added fewer jobs than anticipated in January, signalling a continued moderation in labour market conditions at the start of the year. Private sector payrolls rose by 22 000, following a downward revision to the prior month. Against this backdrop, the Federal Reserve left policy rates unchanged at its January meeting, maintaining a cautious stance as policymakers assessed the balance between easing inflation and a cooling labour market. European equity markets delivered solid gains in January, rising 4.45%, supported by easing inflation pressures and stable monetary policy expectations. Eurozone headline inflation softened further in January, falling to 1.7% year on year, below the ECB's 2% target, while core inflation eased to 2.2%, reflecting broader normalisation in price pressures. Against this backdrop, the European Central Bank kept its key interest rates unchanged, maintaining the deposit rate at 2% and signalling confidence that inflation will stabilise around the target over the medium term despite the recent dip.

Emerging markets delivered a strong start to the year, with the MSCI Emerging Markets Index rising 8.85% in January with pronounced divergence on a country level. South Korea and Turkey were the standout performers, advancing 25.9% and 23.7% respectively. In South Korea, equities rebounded sharply, supported by strength in technology and semiconductor stocks alongside the government's market support and corporate value-up programme, which helped improve investor confidence and capital market sentiment. Turkish equities also posted outsized gains, reflecting improved investor sentiment and continued capital inflows. By contrast, India and Indonesia were the main detractors, declining 5.1% and 5.6% respectively, as investors reassessed near-term growth and policy dynamics. Overall, January performance highlighted the continued importance of country specific drivers within emerging markets.

On a sector level, Information Technology was the best performing sectors over the month, where the fund's underweight detracted from relative performance. The fund's overweight holdings in Materials & Financials added to relative performance, while stock picking in Communication Services added to relative performance. Notable portfolio actions during January included initiating a new position in Polycab and Wistron, while existing positions in Tencent, Alibaba and Northam Platinum were topped up at attractive levels.

Notable contributors to fund performance were positions in Samsung (+99bps absolute and -29bps relative), TSMC (+98bps absolute and -28bps relative) and SK Hynix (+50bps absolute and -34bps relative). Notable detractors from performance over the month came from Naspers (-45bps absolute and -40bps relative), Trip.com (-20bps absolute and -14bps relative) and Kaspi (-19bps absolute and relative).

The fund is overweight in Kazakhstan and South Africa, where we continue to find compelling bottom-up opportunities. Conversely, the fund remains underweight India, Taiwan and China, with India and Taiwan continuing to trade at elevated valuations relative to broader emerging market peers.

The Fairtree Global Emerging Markets UCITS Fund was successfully launched on 1 December 2025, providing an offshore entry point for investors. The existing Fairtree Global Emerging Markets Prescient Fund will convert into a Rand-based Feeder Fund during February 2026.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

High Water Mark: The highest level of performance achieved over a specified period.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Performance fee incl. in TER (%) PF (%): The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Specific Risk
