- ANNUALISED PERFORMANCE: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- AVERAGE CREDIT QUALITY: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).
- AVERAGE DURATION: The weighted average duration of all the underlying interest bearing instruments in the Fund

DIVIDEND VIELD: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

- IGH WATER MARK: The highest level of performance achieved over a specific period.
