ABOUT THE FUND

The Fund is actively managed on a discretionary basis to provide stable long-term growth with moderate level of risk. The Fund shall be within 2 years of the modified duration of the BEASSA Total Return Index.

INVESTMENT STRATEGY

The Fund aims to deliver a return in excess of the benchmark over the long term, which comprises a reasonable level of income, as well as capital performance relative to the benchmark. The portfolio will invest in interest bearing and non-equity securities (including, but not limited to, government or quasi-government bonds, corporate bonds, cash deposits, money market and other interest-bearing securities), as well as listed and unlisted financial instruments in line with appropriate regulations. The investments are actively managed and will change over time to reflect a macro fundamental outlook including the interest rate cycle, business cycle, default cycle, as well as other cyclical and credit factors.


The portfolio has adhered to its investment objective and there were no material changes to the composition of the portfolio during the reporting period.





FUND COMMENTARY

The South Africa sovereign yield curve effectively bear steepened against our positioning as volatility spiked as the market is trying to form a view on the possible South Africa election outcomes. This uncertainty and long asset pack positioning has seen bonds, and the rand weaken.

Foreigners' holdings of SA government bonds increased the most in May, followed by "other" financial institutions (unit trusts and financial holding companies, excluding banks, pension funds and insurers) and insurers. These increases were counteracted by declines in the holdings of banks and "other" institutions.

Swaps have outperformed the bonds thereby forcing a lot of pack unwinds. Focus will now be around the various coalition required for the ANC to achieve their majority. Short-term rand volatility, though still relatively high, has moderated somewhat as traders take comfort from early indications that SA may sidestep a so-called "doomsday coalition" - a partnership between the ANC and one or both of the populist parties. But longer-term positioning reflects concern that the country faces a messy political future, no matter what the outcome of the coalition talks.



GLOSSARY

- **Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.
- **Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.
- **NAV:** The net asset value represents the assets of a Fund less its liabilities.
- **Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.
- **Standard Deviation:** The deviation of the return stream relative to its own average.
- **Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.
- **Max Gain:** Largest increase in any single month
- **% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.
- **Average Duration:** The weighted average duration of all the underlying interest bearing instruments in the Fund.
- **Average Credit quality:** The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).

FUND SPECIFIC RISKS

- **Default risk:** The risk that the issuers of fixed income instruments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

This yield is subject to change as market rates and underlying investments change.
