INVESTMENT OBJECTIVE

The objective of the CAEP Controlled CPI+5% Prescient Fund is to generate capital growth well above inflation over a 5-year rolling period.

WHO SHOULD BE INVESTING?

The CAEP Controlled CPI+5% Prescient Fund will provide a solution to investors who can withstand potential capital volatility in the shorter term.

FUND UNIVERSE

The portfolio is comprised of combination of equities, bonds, notes, listed property and assets in liquid form in both local and offshore markets. The portfolio can have a maximum effective equity exposure (including international equity) of up to 75% and a maximum effective property exposure (including international property) of up to 25% of the market value of the portfolio. The portfolio is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time.

INVESTMENT STRATEGY

The CAEP Controlled CPI+5% Prescient Fund is a medium-risk multi-asset class, high equity solution targeting CPI+5% over a rolling 5-year period, providing asset class diversification.

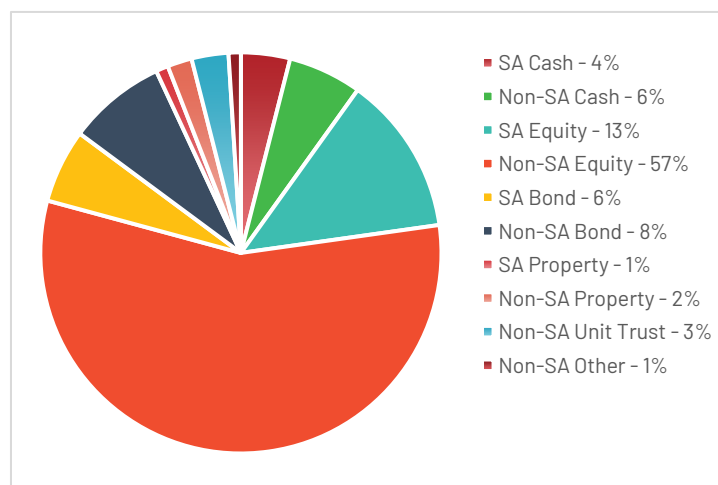

COMMENTARY

The CAEP Controlled CPI+5% Prescient Fund is structured as a medium-risk, high-equity multi-asset solution targeting CPI+5% over a rolling 5-year period. With a fund size of R56.2 million and a net asset value (NAV) of 1.07, the fund aims to generate capital growth above inflation while maintaining a diversified portfolio across equities (61.83%), bonds (19.14%), and cash (18.19%).

The fund has ranked in the top quartile of its category. Its asset allocation strategy includes a blend of local and offshore investments, providing a balanced exposure to risk while maintaining growth potential.

Given its aggressive allocation approach, this fund is ideal for investors who can tolerate market volatility in pursuit of long-term capital appreciation. Investors should note that historical risk metrics such as maximum drawdown (-7.61%) and standard deviation (9.12%) suggest some expected short-term fluctuations. However, its Sharpe ratio of 0.20 indicates a reasonable return for the level of risk taken.

This fund is suitable for investors with a 5-year investment horizon, looking for higher returns above inflation while managing risk through a diversified strategy.

Changes in the composition of the portfolio: There have been no changes in the composition of the portfolio from the end of Q3 2024 to the end of Q4 2024.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Average Credit quality: The weighted average credit quality of all the underlying interest bearing instruments in the Fund (internally calculated).

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

High Water Mark: The highest level of performance achieved over a specified period.
