

Abax Balanced Prescient Fund is a domestic fund focusing on high risk-adjusted returns, balanced across local and global asset classes with maximum 75% equity and 45% foreign exposure. The Fund is Regulation 28 compliant.

The objective is to outperform the peer group on a net of fee basis and is suitable for investors seeking high levels of capital growth and moderate levels of income, who can tolerate the associated high levels of capital volatility. Time horizon: 5 years plus.

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection as well as our hedging and hybrid capabilities.

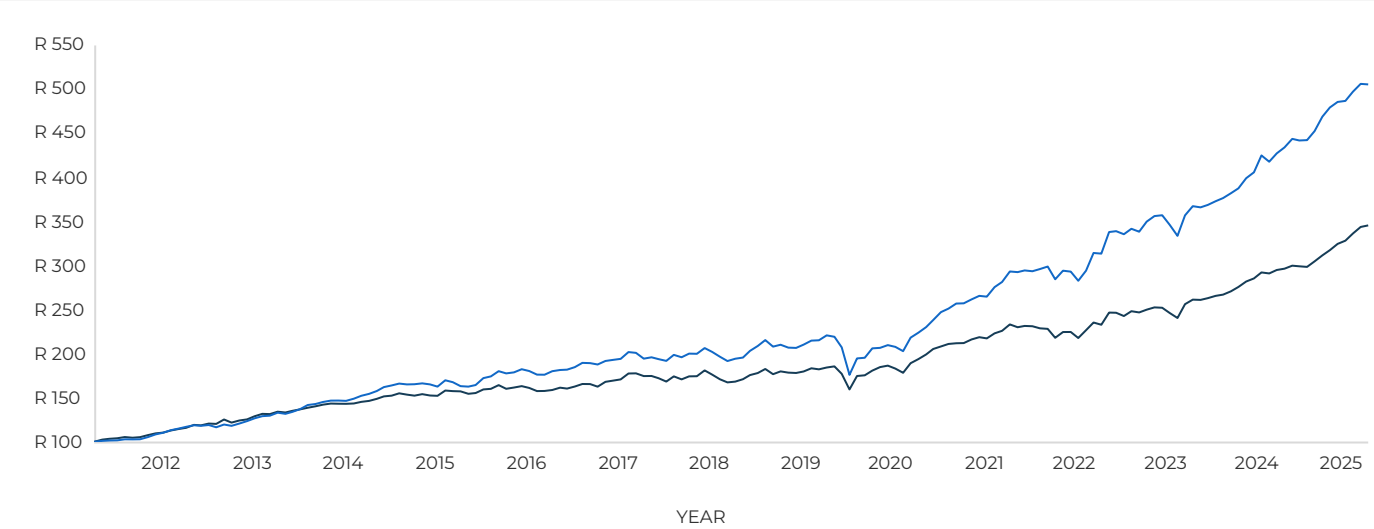

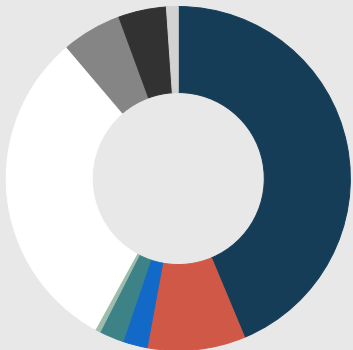

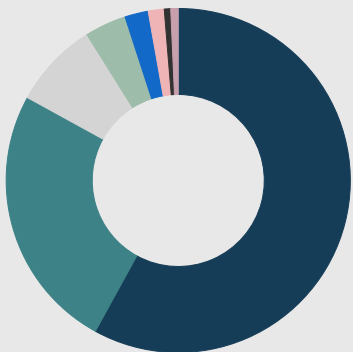

Annualised Performance: Longer term performance rescaled to a 1-year period and is the average return per a pear, per period. Actual figures available on request.
