



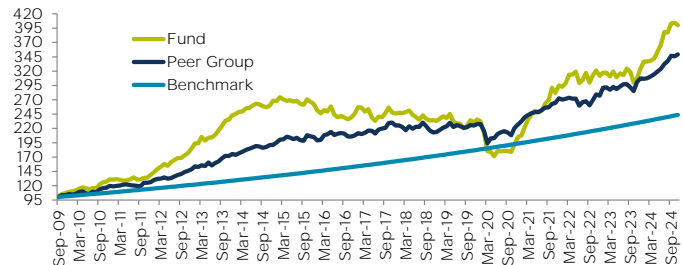
FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

MONTHLY COMMENTARY

It was a difficult month for the fund, with several of our larger holding beset with short-term issues. Grindrod has been impacted by the political unrest following the contested elections in Mozambique. We believe a political compromise will be reached with the appointment of a new Mozambique president in January to replace the outgoing President Nyusi. We also anticipate the publication of the Network Statement and toll fees by the Department of Transport which will allow Grindrod to start rail operations in South Africa from January.

Nampak was down over 15% after the publication of earnings guidance with little further detail. The chairman apologised to investors several days later for the miscommunication and the subsequent results presentation showed a very strong recovery, with demand for beverage cans so strong that brewers were on allocation for the 500ml can format. Nampak will have an additional 30% capacity increase for beverage cans with little additional capital investment over the next 3 years as demand continues to grow at 5 to 6% per annum. Demand for beverage cans is driven by shebeen owners' insistence for cans, soaring demand for energy drinks and new format launches such as wine in a can. An interesting product about to hit the shelves is cooked chicken in a can as another easy protein offering for consumers.

ASP Isotopes was hit by an anonymous short selling twitter account which the company called "speculative conjecture, inaccurate and filled with innuendo". Having undertaken two site visits to their CSIR based facilities and considering that the leading Small Nuclear Reactor developer, Bill Gates backed TerraPower, selected ASP Isotopes to supply nuclear fuel, we would agree with the companies view on the anonymous attack. ASP announced the start up of the silicon 28 facility which will supply semiconductor fabs with silicon 28 which will increase the speed of the chip while reducing power consumption and heat. This revolutionary product could have significant implications for semiconductor companies.

On a positive note, MAS Real Estate announced another cautionary citing ongoing negotiations with Prime Kapital that aim to better align the relationship between the two companies, causing the share price to lift and start to narrow the huge gap to NAV.

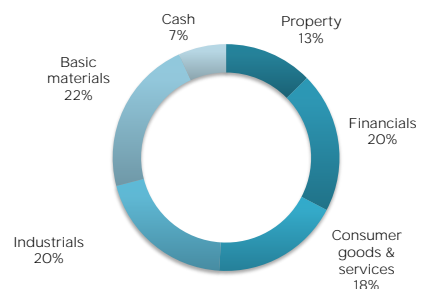
