



**Investment Objective**





Income Distribution:



MARKET COMMENTARY

The fund returned 2.23% for the month, outperforming the benchmark by 1.18%, while the MSCI ACWI Index gained 1.05%. Germany and the United Kingdom were the strongest performers, rising 4.4% and 3.8% respectively, while China recorded the largest decline, falling 1.2%. The MSCI Emerging Markets Index rose 3% over the month. Within emerging markets, South Korea and South Africa posted strong gains of 9.4% and 9.1%, while Brazil and China were the main detractors, declining 1.3% and 1.2% respectively (all figures in USD).

The US market delivered a rare underperformance against MSCI ACWI for the year, but its weight in the index remains elevated at ~64%. It previously peaked at ~55% in 2003 before bottoming at ~41% during 2008-2011. US equities were flat in December, as year-end policy decisions and moderating macro data shaped investor sentiment. The S&P 500 edged up marginally by 0.06%, while the Nasdaq declined 0.67%. Inflation data released during the month showed headline CPI rising 2.7% year-on-year in November. Labour market conditions continued to soften, with unemployment edging higher to around 4.6%, its highest level in several years, underscoring weaker hiring momentum. Against this backdrop, the Federal Reserve cut policy rates by 25bps at its December meeting, lowering the target range to 3.50%-3.75%. This marked the third consecutive rate cut in 2025, as policymakers balanced slowing job growth against elevated inflation.

Overall sentiment remained cautious but constructive toward the year-end. European equity markets advanced 3.9% in December, supported by easing inflation pressures and stable monetary policy expectations. Eurozone headline inflation fell to the ECB's 2% target, while core inflation eased to 2.3% year on year, signalling a continued normalisation in underlying price pressures. The European Central Bank kept its deposit rate unchanged at 2% at its December meeting. Stable policy expectations and easing inflation concerns underpinned the strength of the equity market across the region, with Germany outperforming as disinflation progressed more quickly and fiscal support bolstered confidence.

Emerging markets advanced 3% in December, with performance driven by pronounced country-level divergence. South Korea and South Africa were the strongest contributors, rising 9.4% and 9.1% respectively. In South Korea, equities benefited from a rebound in technology and semiconductor-related stocks, supported by improving sentiment around the global electronics cycle and easing inflation expectations. South African equities were boosted by a combination of lower global interest rates, improved domestic policy credibility following the sovereign rating upgrade, and strength in financials and resource-linked stocks. By contrast, Brazil and China detracted from performance, declining 1.3% and 1.2% respectively. Brazilian equities consolidated after strong prior gains, as investors reassessed the pace of future monetary easing, while Chinese markets remained under pressure amid ongoing concerns around domestic growth momentum and the property sector.

On a sector level, Financials was the best performing sector over the month, where stock picking detracted from relative performance, as well as the fund's underweight exposure to the Industrials sector. The Communication Services sector was the worst-performing sector, where the fund's underweight positioning added to relative performance. Stock picking in Information Technology and the Materials sectors contributed to relative performance.

Notable portfolio actions during December focused on adding to high-quality businesses following market pullbacks. We increased exposure to Nvidia, Microsoft, Naspers, and initiated a position in Tencent, taking advantage of more attractive entry points across long-term structural growth themes. New positions in Dell Technologies, Stryker and Boston Scientific broadened exposure to enterprise infrastructure and high-quality healthcare, while an addition to AutoZone increased exposure to a defensive consumer business with strong cash generation. We exited our positions in EPAM Systems and Canon following strong performances, reallocating capital to higher conviction opportunities in the portfolio, as well as Pinduoduo.

Notable contributors to fund performance were positions in Naspers (+27bps absolute and relative), Impala (+27bps absolute and relative) and Nvidia (+22bps absolute and -4bps relative). Notable detractors from performance over the month came from Broadcom (-17bps absolute and +11bps relative), Alphabet (-8bps absolute and -10bps relative) and Microsoft (-8bps absolute and -2bps relative). The fund is positioned with an underweight in cyclical names, in favour of technology exposure. From a geographical perspective, the fund remains underweight in the US and Canada, while being overweight in Kazakhstan and South Africa.

Reflecting on the performance of the fund over the past year, it was pleasing that the fund outperformed the benchmark by 2.27% for the year, given the concentrated nature of the market's performance. The top 5 performers contributed just below 8% to the 17.86% delivered by the S&P 500 total return for 2025. Only around 30% of stocks in the S&P500 were able to outperform the index. This is the third consecutive year that market breadth has been this narrow and is only matched by the Dot.com period. Normally, 45 to 50% of stocks outperform the index.



Glossary

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest Performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Sortino Ratio: A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Performance Fee Cap: The maximum performance fee that can be charged over a specified period

Specific Risk

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
