

**FUND OBJECTIVE & STRATEGY**

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

The fund is a high risk, high return fund and should be invested in as a complementary investment to any long-term blue-chip portfolio.


RISK INDICATOR

MONTHLY COMMENTARY

We lamented the pullback in Pan African Resources last month caused by the gold price pausing its ascent. Fortunately November delivered a strong month with Pan African Resources up 18%, making Pan African Resources our largest holding. China currently holds 8% of their foreign reserves in gold versus the United States at 75%. We anticipate gold demand to remain strong as rising inflation expectations and sovereign risks of holding treasuries pushes many central banks towards higher gold holdings. Southern Sun delivered decent numbers for the first half of the year, normally the quieter period, especially considering their Seychelles Hotel was closed for the full period for a major renovation. Seychelles normally contributes R43m of EBITDA per half and the relaunch of Seychelles will benefit the second half earnings. Occupancy in October, which falls in the second half, was at 73.3% - a level last seen during the 2010 Soccer World Cup.

Reunert delivered a 12% decline in annual results which was an improvement on the first half. For a group that operates in booming energy and defence markets this is a disappointing outcome. The defence operating profit, for example, moved from R103m in 2021 to R500m this year. Unfortunately, the divisions outside of these two high growth areas are pulling the group results down. In a surprise move the CEO is stepping down to be replaced by the ex-CEO of Ethos Private Equity which is likely to bring some major changes.

The fund holds Hualamin and Nampak, for whom the aluminium price is a key variable. The aluminium price is being driven higher by surging power prices which are in turn being pushed higher by the fact that those needing power for AI data centres are prepared to pay \$100/mw for power, in comparison to the aluminium smelters who have paid \$40/mw. This is clearly problematic for Nampak and Hualamin and they are both trying to de-gear their balance sheets as a higher aluminium price soaks up additional working capital. The fund had an 8% weighting to aluminium between these two companies and we have reduced these holdings appropriately.

We are holding thumbs on a Grindrod announcement on the running of the first private rail service in December which would be a great finish for 2025!


