



**Investment Objective**

The Fairtree Global Real Estate Prescient Feeder Fund aims to provide access to high quality, international real estate assets that should benefit from capital appreciation while also delivering solid foreign dividends. The fund aims to outperform its benchmark by analyzing the central economic and political drivers in the various geographies, identifying global property sector trends and studying the specific physical property market and equity fundamentals.

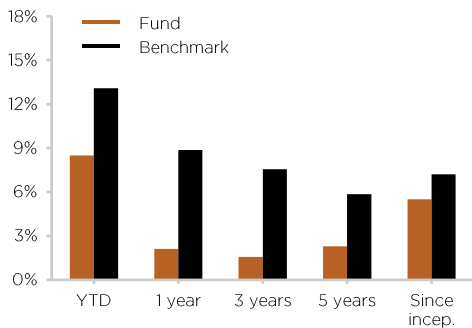
**Investment Policy**

The portfolio has a long term focus, and is well diversified across geographic regions, currencies, real estate sectors and stocks. We will combine our top-down fundamental property market research with rigorous statistical valuation analysis using our proprietary models. We aim to lower portfolio volatility by adjusting the stocks and cash levels actively, while still outperforming our benchmark. We practice active risk management on a portfolio, sector and stock basis including the dynamic use of targets and stops. The fund will invest primarily in real estate equities in the United States, Japan, Hong Kong, Singapore, Australia, Europe and the UK.

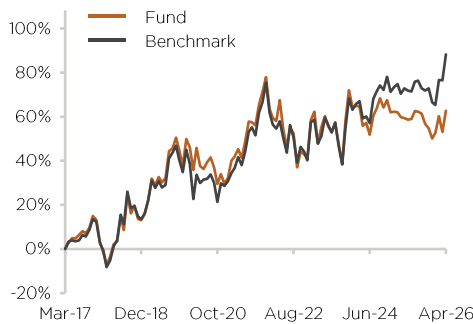
**RISK INDICATOR**

MARKET COMMENTARY

In April, the underlying fund was up 7.91% while the index was up 8.52%, resulting in 60bps of underperformance, which was largely driven by the first and second bites of the apple, region and sector, which hit performance by 65bps. The third bite of the apple, stock selection, had a positive impact on performance of 15bps. We held around 5% cash this month, lower than the previous months, but still above our usual 3% holding, which had a marginal negative impact of 10bps. The Developed Property Index underperformed the S&P 500 for the month, although for the year it is still comfortably ahead. The US-Iran conflict has caused oil prices to rise, increasing inflation and interest rate expectations, but the market has largely shrugged off these headwinds thus far, which we view as a concern.

April was a strong month for property stocks, with all geographies in the green. Australia was the best-performing region, up 14%. We are underweight, although our exposure to index heavyweight Goodman Group worked well as it led the stocks higher, up 21%, as their data centre pipeline garnered more interest. In second place, the UK was up 9%, retracing its March fall, and we remain overweight on stock specifics despite interest rate concerns. The US was in third place, up slightly less than 9%, and we have reduced our underweight in this region substantially by increasing our exposure to the data centre and healthcare sectors. At the opposite end of the spectrum, the weakest region was Japan, with the REITS and developers up only 4-5%. We remain underweight as valuations are unattractive, interest rates are rising, and the economy is slowing. Singapore was the second weakest, their REITS and developers up 5-6%, and we remain underweight as valuations are full and there are better opportunities elsewhere. The EU was third weakest, up 6%, but we remain overweight given attractive valuations and stock-specific ideas.

All of the US property sectors were up for the month. The top performing sector was office, up 13%, where we are neutral as attractive valuations are offset by still challenged fundamentals. Data centres were in second place, also up 13%, and we have moved to overweight as supply estimates are likely to be revised downward over the coming years due to a lack of power and construction workers. Lodging was in third place, up 11%, where we have no exposure, as we expect higher oil prices to hit travel demand. Industrial was up 8%, and we are currently reviewing our overweight positioning after a good run. Healthcare was also up 8% and we have reduced our underweight substantially by increasing our exposure to senior housing, given their strong fundamentals. The weakest performing sector was net leases, up only 5%, which one should expect given their low-beta nature. We remain overweight as we prefer their defensive qualities, given that the market has shrugged off the Middle East conflict, perhaps too easily. Shopping centres were up only 6%, again a reflection of their more stable nature, and we are overweight in this sector for the same reasons.

The best-performing stock in our portfolio for the month was Aussie industrial and data centre stock Goodman Group, up 21% as mentioned above. Next best was US office behemoth BXP, up 13%, off attractive valuations. Third best was US residential stock Avalon Bay, up 12%, as first-quarter results were decent and a potential merger with Equity Residential was announced. At the opposite end of the spectrum, US life science stock Alexandria was down 13% after first-quarter results again disappointed the market, with a recovery in the space only now expected in 2028. Similarly, medical office stock Healthpeak was the second weakest performer, down 2%, and we exited this position during the month. In third place, US-manufactured housing stock, Equity Lifestyle, was up only 1%, again mostly a reflection of its stability.

The month ended on a positive note for investors, with some solid first-quarter results which boosted returns. We continue to review results as they are released and position ourselves to benefit from sectors and stocks with improving fundamentals. We are cautious of the continued impact on the markets from the ongoing wars and are defensively positioned at this juncture. We are currently integrating new valuation tools into our process to improve efficiency and generate new ideas and hope to reap the benefits through stronger performance over the coming years.

**Glossary**

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%):** The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

**Transaction Costs (TC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
