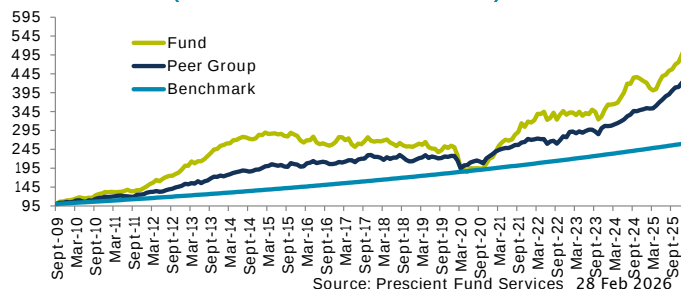


**FUND OBJECTIVE & STRATEGY**

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

**WHO SHOULD INVEST**

**MONTHLY COMMENTARY**

Future Titans was up 3.48% for the month against the Flexible Index of 2.67%. Pan African Resources was a strong performer, as gold moved higher and the company delivered a strong set of results which highlighted the multiple growth opportunities in their South African and Australian portfolios. This contrasts with many other gold companies who don't have expansion opportunities to maintain output as their existing mines become depleted. Importantly, one of Pan African's largest expansion projects is the Soweto tailings dump project which is capex and labour light, providing fantastic returns for shareholders.

Araxi, a point of sale payments provider with banking software, acquired Pay@ utilising most of Araxi's cash holdings and putting debt on the balance sheet for the first time. Pay@ is the largest independent payments processing channel with 9000+ retailer locations, 150 000+ mobile POS payment end points processing over R60bn in transactions in the past year. Importantly, management retain their 20% and Araxi are buying out the two private equity investors. We see this providing good growth to the company in the years ahead.

The tranquil February markets were thrown into volatility on Saturday the 28th of February as the Iranian conflict started. The principle concern in financial markets is the insurance-driven closure of the Straits of Hormuz which is a choke point for oil and many other important commodities. Whilst most media commentary is on oil, it is the least of the worries due to large global stockpiles. More important is LNG, refined diesel, fertiliser, aluminium and sulphur required to make sulphuric acid for copper production where global stockpiles are significantly lower. All these commodities are essential and do have substitutes but will spike global inflation which in turn delays or potentially stops further interest rates cuts from here. This is not the first time the Strait of Hormuz has been used during a time of war to choke shipping. During the Iran/Iraq war in the 80's both parties attacked a total of 451 tankers transiting the strait which resulted in the US Navy running convoys.

Whilst conflict is never good for financial markets, volatility does tend to also bring opportunities.

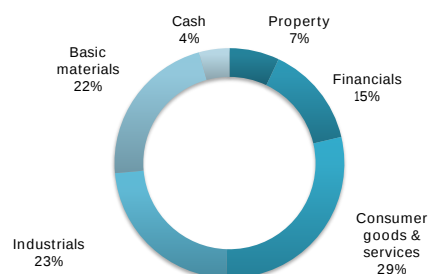
