The Fund aims to achieve long term capital growth appreciation over a full market cycle by maintaining meaningful exposure to growth assets like equities.


INVESTMENT POLICY

ANNUALIZED PERFORMANCE (%)





CUMMULATIVE PERFORMANCE



FUND COMMENTARY

The S&P 500 surged by 23.3% in 2024, marking its second consecutive year of +20% gains and fourth in six years. Tech giants like Nvidia (+172%), Meta (+65%), and Apple (+36%) fueled the growth, with the Magnificent Seven (including Tesla, Microsoft, Amazon, and Alphabet) driving nearly half of the index's gains. The 12%-pt contribution of the other 493 stocks points to other drivers as well: Fed's interest rate cuts, a resilient US economy, strong earnings growth, and anticipated tax cuts and regulatory easing. As US stocks dominate the MSCI All World Index (c.67% share at the end of November), the global benchmark also has a good year (+17% in USD). The shortfall is however indicative that other share markets did not fare nearly as well. MSCI Europe was up only 4.7% (in euro), MSCI Pacific just 4.6% (in dollars). This belies some strong regional returns: the DAX gained 18.8%, the Nikkei 225 19.2% and the Hang Seng 17.7%. The US 10-yr yield has risen from 3.6% to 4.6% since September. This is not an equity-valuation problem if the higher rate reflects higher economic growth or inflation expectations (which should also come through in revenue growth). But if it reflects a higher risk premium related to Trump's presidency, or the high budget deficit and growing debt levels, this may be another factor pulling back the S&P500 in December. 10-yr yields rose in all DMs but not nearly as much, indicative that this a US-specific issue.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product
