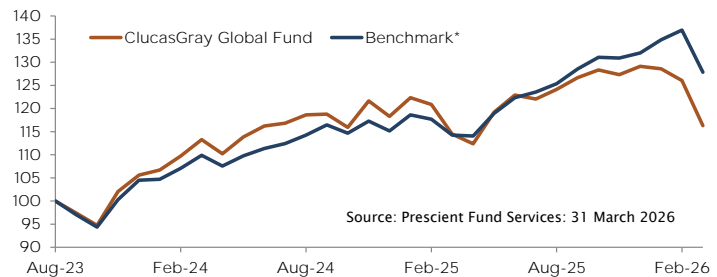



FUND OBJECTIVE & STRATEGY

The investment objective of the Fund is to provide long term capital appreciation and income growth through investment in a concentrated portfolio of assets. The fund is primarily exposed to a focused portfolio of developed market equities. The fund is managed on the basis of the long term ownership of assets and has a bias towards high quality ideas. Investors with a time horizon of three to five years are ideally suited to this fund.

MONTHLY COMMENTARY

The ClucasGray Global Fund declined 7.8% in March while the Morningstar Aggressive Allocation peer group fell 6.7%.

Global equities started 2026 with a sharp reversal of the market leadership that characterised 2025. US equities and high-growth technology companies came under pressure as investors rotated into value-oriented sectors and non-US markets. Safe-haven assets, such as gold, surged throughout the period as geopolitical risks escalated. March saw the outbreak of direct military conflict in Iran, triggering a surge in oil prices as markets priced in the risk of disruption to a critical global energy corridor. The broader market impact was sharply negative, with the MSCI All Country World falling 7.4% in the month, as rising energy costs stoked inflation concerns, increased uncertainty over the economic outlook, and clouded the path for global monetary policy.

On a sector basis, Q1 was marked by a dramatic sell-off in Software & Services stocks (-24.0%), as the rapid proliferation of AI workflow tools prompted a broad and largely indiscriminate de-rating of the sector. Despite generally robust quarterly results reported by the large incumbents, sentiment towards the sector remained acutely negative. The Energy sector was the quarter's clear outperformer, rising 32.6%, driven in large part by the sharp oil price dislocation seen in March.

The Fund's top-performing holdings over the quarter were ASML (+23.5%) and TSMC (+11.2%), which continued to benefit from extraordinary AI-driven demand for leading-edge semiconductors. PepsiCo (+8.2%) and Anheuser-Busch (+7.0%) also demonstrated the defensive appeal of quality consumer staples in a volatile environment. The Fund was disproportionately affected by the software sector sell-off, with Intuit (-34.7%), Salesforce (-29.5%) and Microsoft (-23.5%) among the largest detractors. LVMH (-29.4%) also weighed on performance.

During the quarter, the Fund initiated new positions in Schneider Electric, a leading global player in electrification, and Broadcom, which specialises in custom AI chips. The Fund also added diversified exposure to major US and international defense contractors through the Global X Defense Tech ETF. During the March sell-off, the Fund took advantage of a rare valuation opportunity to initiate a position in Ferrari. Within the software sector, the Fund consolidated the number of sector holdings, concentrating capital in those names where we believe the competitive moat is most durable.

At the end of March, the Fund had an underlying exposure to equities of 99.9% and 0.1% in cash.

The Fund has adhered to its investment policy.

The number of participatory units at 31 March 2026 was 396 665.

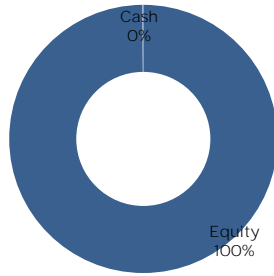

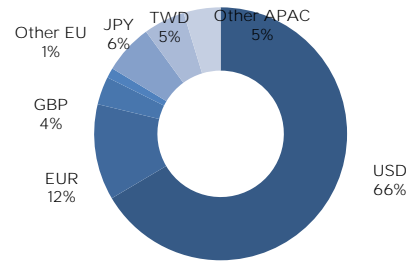

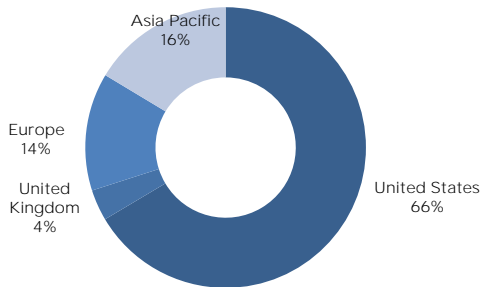
FUND ASSET ALLOCATION



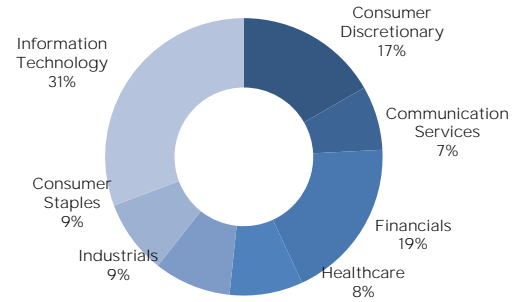
NET CURRENCY EXPOSURE

A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Months: The percentage of months since inception where the Fund has delivered positive returns.
