MONTHLY COMMENTARY

The ClucasGray Global Fund declined 0.8% in November while the Morningstar Aggressive Allocation peer group retreated 0.1%.

Global equities ended November modestly lower, although this masked sharp intra-month swings. The MSCI All Country World Index dropped 3.7% before rebounding into month-end, amidst investor concerns about elevated technology valuations and the capital requirements to build out Al-related processing infrastructure. Large technology names that dominate the Al space traded broadly lower, dragging the Information Technology sector down 4.9%, while out-of-favour defensive sectors such as Healthcare (+7.8%) and Consumer Staples (+3.5%) outperformed, as investors rotated toward stability.

Technology jitters overshadowed broadly positive corporate earnings, where more than 80% of S&500 companies beat Q3 profit expectations, delivering average year-over-year earnings growth of 13%. Robust growth reported by large-cap technology companies have continued to be key driver of overall earnings. Meanwhile, delayed US economic data - a result of the government shutdown - clouded the macro picture, but ongoing softness in US labour markets supports the case for further interest rate reductions, with consensus pointing to a 25bps cut at the Fed's December meeting.

The Fund's top performing holding in November was Alphabet (+13.9%), which reported stellar Q3 results. Strong traction of its Al model, Gemini, has shifted the market's perception of the company from Al-loser to Al-winner, driving a sharp re-rating of the stock in recent months. Leading US hospital operator, HCA Healthcare (+10.6%) also performed well, delivering consistently strong financial results, notwithstanding an uncertain regulatory environment. The leading detractor to Fund performance was Nvidia (-12.6%). Despite reporting a 62% year-over-year revenue increase and reiterating confidence in cloud infrastructure demand, investor unease over the rapid pace of data center expansion weighed on the stock.

At month-end, the Fund had an underlying exposure of 98.0% to equities and 2.0% cash.






FUND ASSET ALLOCATION




NET CURRENCY EXPOSURE
