INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve returns above the STeFI Call Index and the average money market fund, while minimising the risk of any underperformance. Importantly, the Fund is managed conservatively and it aims to maintain capital stability and liquidity.

INVESTMENT PROCESS

The Fund invests in cash, money market and high-quality capital market (nominal or real) instruments including structured notes. Fund performance can be generated from taking interest rate or duration views, yield enhancement via credit instruments and also via the use of derivatives.

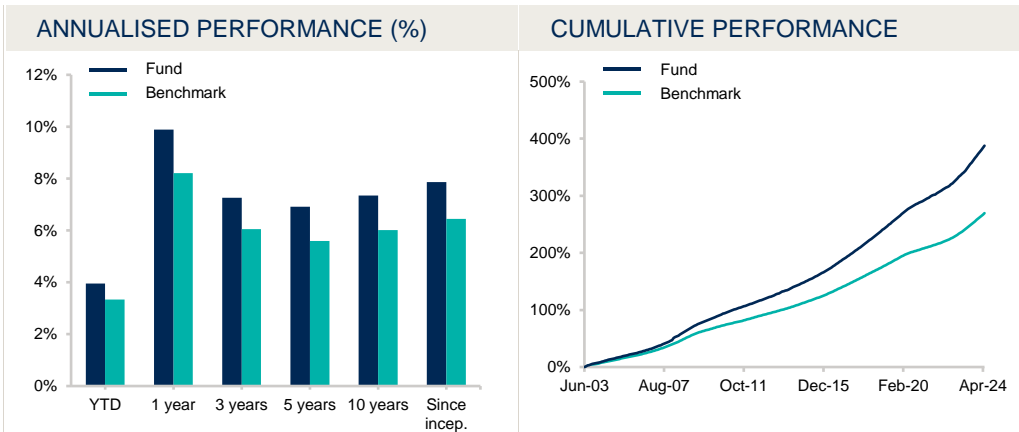
WHO SHOULD INVEST

Investors seeking a liquid, low risk money market offering, with enhanced yields. This Fund is suitable to investors with a short-term investment horizon and is Regulation 28 compliant.

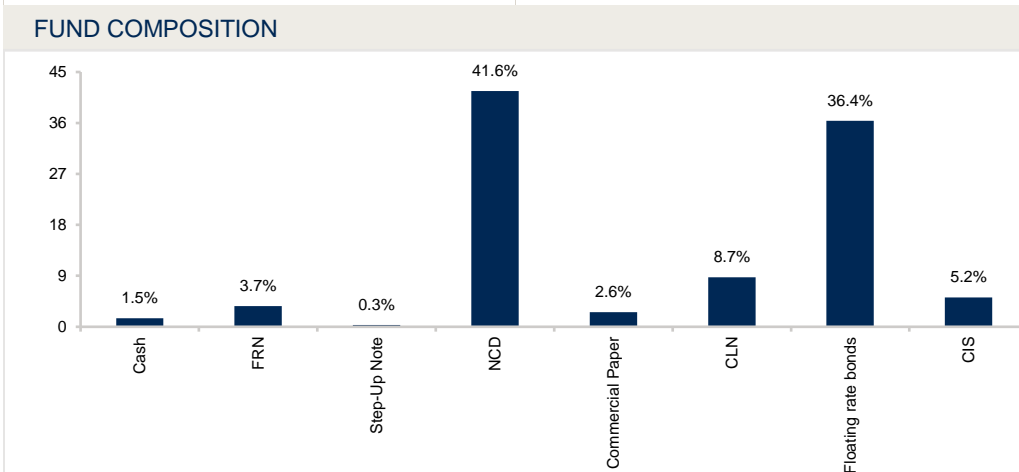
RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

FUND COMMENTARY

The South African Reserve Bank maintained the repurchase rate at the May Monetary Policy Committee Meeting, with all members in agreement. The Reserve Bank has slightly adjusted its inflation forecast for 2025, revising it down from 4.6% to 4.5%. It now anticipates inflation to stabilize at the midpoint of 4.5% in the second quarter of 2025, earlier than previously expected, which was by the end of the year. This adjustment follows lower-than-expected inflation releases in March and April, prompting the SARB to make marginal revisions to both the food and core components for 2024.

The 12-month NCD rate rallied close to 10ps and the 3-month Jibar rate relatively unchanged over the month.

The forward rate agreements (FRAs) repriced now expecting the first cut at year end of 2024 but not much more rate reduction expected further out in the FRA curve closer to the two-year point.

The Fund had a good performance month during May. The positive yielding assets added to the return for the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.

Forward Yield: The Forward Yield is the expected combined income of the instruments in the portfolio over the next year expressed as a percentage of the current value of those instruments.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.
