



# FUND COMMENTARY

Looking at SA asset classes, the Capped Swix was down 0.38% in February, SA Property was up 0.27%, with the All Bond Index up, 0.07%. Offshore asset classes, the MSCI All Country World Index was down 0.60%, Offshore Property was up 1.74%, with Offshore Bonds also up, 1.23% (All these returns are in US Dollars).

Looking at 1 year returns to the end of February 2025, Local equities outperformed Offshore equities, with SA property and SA fixed income producing healthy double digit returns. The Rand strengthened by approximately 2.4% versus the USD over the year.

## GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any I year over the period since inception have been shown.
