## GENERAL INFORMATION

Collective Investm ent Schemes in Securities (CIS)should be considered as medium to long-term investments. Forward pricing is used.

### TOTAL EXPENSERATIO (TER)

The Fund's Total Expense Ratio (TER)reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year.

### TRANSACTION COSTS (TC)

Transaction Costs (TC)is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

#### TOTAL INVESTMENT CHARGE

The sum of the TERand transaction costs is shown as the Total Investment Charge. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns.
