



**Investment Objective**





## MARKET COMMENTARY

In December, the fund outperformed the benchmark by 90bps, as it was down 28bps and the benchmark was down 118bps. The performance was mainly driven by the third bite of the apple, namely stock selection, which contributed 71bps, while the first and second bites of the apple, namely region and sector allocation, increased performance by 21bps. We held around 7% cash, which had no material impact on performance. The Fed cut rates in December but developed market property stocks still underperformed South African and Global equities. Within property, we remain strategically positioned to benefit from Asia over the US.

The best-performing region this month was Singapore, with developers up 5% and REITs up 1%. We are neutral on Singapore as stellar performance in 2025 has led to full valuations, but they continue to benefit from low interest rates and a resilient economy. Australia was the second-best performer, up 2%, and we reduced our overweight by adding Goodman to the portfolio during the month. The UK was the third best performer, up 2%, and is our second largest overweight. The BOE cut interest rates during the month, which should reduce debt costs and support valuations. Japanese REITs and developers were flat for the month as the BOJ raised rates as markets expected. The weakest performing region was the US, down 3%, where we have a substantial overweight as valuations are less attractive and fundamentals are weak in certain sectors. HK was the second weakest region, with REITs and developers down 1-2%. This is our largest overweight region, and valuations remain attractive despite phenomenal returns in 2025.

All the US sectors were flat or down for December. Our most overweight sector was shopping centres, which was the top performer for the month as it remained flat, followed by our most overweight sector, residential, which was also flat. We prefer the valuations and growth associated with shopping centres over malls, while we least prefer residential, as vacancy rates and rents still need to stabilise. Malls were third, also flat for the month. At the opposite end of the spectrum, healthcare was the weakest performer, down 9% for the month, after being the top-performing sector YTD. Valuations remain full, and we remain significantly overweight. Offices were the second weakest performers, down 7%, where we have no exposure given weak fundamentals. Storage was the third worst-performed, down 4%, where we are also overweight due to weak fundamentals.

The best-performing stock in our portfolio for the month was UK student housing stock Unite, up 8%, which finally rebounded after being hammered for most of 2H25 following on from weak 1H25 results. We believe that the UK student housing fundamentals are more solid than the share price would suggest. Australian industrial and data centre stock Goodman was second, up 6%, and we believe more upside is likely over the coming year as the company announces more capital partners in its data centre roll-out. Hong Kong developer New World Development was also up almost 6%. Valuations are still attractive, and we expect more upside as the likelihood of bankruptcy recedes. At the opposite end of the spectrum, the weakest performing stocks were all involved in US healthcare. Medical office stock Healthpeak Properties was down 12%, followed by senior housing stock Welltower down 11%, and life science stock Alexandria Real Estate down 9%. We are overweight the sector but do believe some value is emerging in certain sub-segments.

The year concluded with better relative performance for the fund, given our preference for Asia over the US. We maintain that preference as we enter 2026 and prefer the EU and the UK over the US too. We remain relatively optimistic on global REITs versus the overall equity markets in 2026, given the large discount that they are currently trading at, and with interest rates likely to fall further in 2026. We wish you all the best for 2026.

### Glossary

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**Total Expense Ratio (TER):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

**Transaction Costs (TC):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
