## MINIMUM DISCLOSURE DOCUMENT

### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to consistently achieve returns above the (ASISA) South African General Equity category over the medium to long term. The Fund is managed systematically to outperform the peer group average return whilst maintaining similar risk characteristics.

### INVESTMENT PROCESS

The Fund uses quantitative techniques to dynamically construct a portfolio that is most representative of the general equity category average then employs uncorrelated return enhancement techniques combined with efficient and cost-effective portfolio construction methods to generate outperformance. Although the fund is always fully exposed to the equity market, the use of fixed interest portable alpha techniques to enhance returns can provide exposure to cash and money market instruments, which are uncorrelated and reliable sources of additional return.

### WHO SHOULD INVEST

Investors seeking broad based exposure to the South African equity market with consistently above average returns. This Fund is appropriate for investors with a long-term investment horizon.

### RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

## FUND COMMENTARY

Global equity markets continued to deliver a mixed bag of mostly positive performance numbers in May. Developed markets continued to lead the pack with the MSCI World index returning an impressive 4.47%, making new all-time highs and erasing the losses suffered in April, to close the month up 9.52% year-to-date. This was evidently driven by US in the aftermath of another technology sector surge and a solid earnings season. Similarly, European markets rebounded from the previous month's pullback, on the back of seemingly renewed economic confidence and upward revisions to growth estimates. The S&P 500 index and the Eurostoxx index return 4.96% and 3.34% for the month respectively and brought their respective year-to-date returns to 11.30% and 6.76%. Further east, however, the CSI 300 index in China bucked the trend by giving back -0.85% for the month. This ended a three-month streak of positive performance following underwhelming economic data releases. In Japan, the Nikkei 225 index returned to positive territory, recovering from the heavy losses of the preceding months to close the month up 0.39%. With rate cuts obstinately pushed out and the prevailing macroeconomic dynamics, the broader emerging markets continued to lag their developed market counterparts. The MSCI Emerging Markets Index concluded the month with a gain of 0.56%, bringing its year-to-date return to 3.41%.

Despite another 'unchanged' verdict for interest rates by the South African Reserve Bank, the local equity market rallied considerably in the build up to the potentially pivotal national government elections. The market however pared most of these gains on the back on the uncertain election outcome. Industrials were the best performers, up 1.66% and Financials were the notable detractors down 0.68%. The rand, for the first time this year, traded at just over 18.02 to the US dollar before weakening to 18.79 as election results trickled in, closing the month 0.06% weaker.

The Fund's benchmark closed the month with a gain of 1.40%. The Fund slightly lagged the benchmark, posting a return of 1.38% (gross of fees) for the month.

### Contributors to Performance:

The positions that contributed most to the absolute performance of the fund for the month were Richemont (+12.68%), Naspers (+3.35%) and Prosus (+5.79%).

### Detractors from Performance:

The largest detractors from the month's absolute performance were Gold Fields (-5.80%), MTN Group (-9.41%), and Capitec Bank (-7.15%).

## GLOSSARY

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**CPU:** Cents Per Unit to the Glossary

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Dividend Yield:** The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

**PE Ratio:** The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

## Fund Specific Risks

**Default Risk:** The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

**Derivatives risk:** The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

**Interest rate risk:** The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.
