MINIMUM DISCLOSURE DOCUMENT

INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI World Index Total Return at low cost. Although the Fund is structured similarly to the MSCI World Index, it is not a tracker fund and can out / underperform the MSCI World Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI World Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI World Index or subsets thereof in a low cost and efficient manner.

WHO SHOULD INVEST

Investors who are seeking long term capital growth through diversified exposure to the global markets by investing in a fund with a low tracking error relative to the MSCI World Index and who are cost conscious.

RISK INDICATOR DEFINITION

These portfolios typically hold meaningful equity and/or offshore exposure which may result in significant capital volatility over all periods. Due to their nature expected long term returns are higher than for the other risk categories.

FUND COMMENTARY

Market Context

Equity markets generally traded softer in October. The MSCI World index ended its impressive run of positive months, closing the month down -1.98% in what is one of only two negative monthly prints over the past year. The markets seemingly remain concerned about global growth, employment and inflation. In the US, policy uncertainty took center stage as despite strong labour market data and a decent start to this latest earnings season, the S&P 500 index closed the month -0.98% lower. This comes as the tightly contested US presidential election, with its fiscal and monetary uncertainty entourage, edges ever closer. European markets similarly traded lower despite yet another, albeit well telegraphed, 25 basis point rate cut by the ECB this year. The Euro Stoxx 500 gave back -5.79% in US dollars amidst growth concerns in that region. In Asia, Japan's monetary policy stance and impact on the Yen saw the strength in the local equity market eroded to -3.07% in US dollars whilst China's market cooled off -4.51% after the government sponsored lift off in September. Emerging Markets followed suit, the MSCI EM index down -4.45% in October and underperforming the developed markets. Locally, the South African market was lead lower by the industrial and financial sectors, down -3.07% and -1.06% respectively, while resources clawed back 2.31% as the rand weakened by 1.9% against the dollar.

Fund Positioning

The Fund maintains the maximum effective exposure to the large and midcap sectors of the market. This equity exposure consists of top three allocations to the Information Technology, Financials and Industrials sectors with the largest share exposures to Apple, NVIDIA and Microsoft.

Outlook

We maintain a moderately positive outlook for the domestic equity market. Attractive valuations and with improving sentiment indicators underpin this outlook. The current restrictive monetary policy environment and the relatively high unemployment rate are the largest detractors from our financial conditions and economics indicators for this view.

Fund Performance

The Fund was up 2.04% (gross of fees) in October, underperforming the benchmark, which rose 2.14%. YTD, the Fund is behind the benchmark by 0.30%, with a return of 13.88% (gross of fees).

Contributors and Detractors

The positions that contributed most to the absolute performance of the Fund for the month were NVIDIA (+9.3%), Wells Fargo (+14.9%) and JPMorgan (+5.2%). The largest detractors from the month's absolute performance were Microsoft (5.6%), Apple (-3.0%) and ASML Holding (-16.7%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Interest rate risk: The value of fixed income investments (e.g. bonds) tends to be inversely related to interest and inflation rates. Hence their value decreases when interest rates and/or inflation rises.

Derivative counterparty risk: A counterparty to a derivative transaction may experience a breakdown in meeting its obligations thereby leading to financial loss.

It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
